A BILL FOR AN ACT

RELATING TO PUBLIC LIBRARIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 312, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated

4	"§312- Pilot program for lease of public library land.
5	(a) There shall be established a pilot program for the lease of
6	public library land, including facilities. The state librarian,
7	in consultation with the board of education and any other

10	(b) Notwithstanding section 171-13, or any other law to
11	the contrary, the board of education may lease public library
12	land on terms it deems appropriate, including a leaseback of all
13	or a portion of the improvements constructed; provided that:
14	(1) The board may identify and select up to five public
15	library land sites as candidates for participation in
16	the pilot program; provided that:

1		During the identification and selection process,
2		the board shall be subject to chapter 92, shall

6		(B) If the site is on land owned by the county, the

RELATING TO PUBLIC LIBRARIES

Senate Bill (S.B.) No. 2919, S.D. 2, amends Chapter 312, HRS, by adding a new section to establish a pilot program for the lease of public library land, including facilities. The measure specifies that the State Librarian, in consultation with the Board of Education (BOE) and any other appropriate agency, serves as the facilitator of the pilot program. The measure also specifies that the BOE may lease public library land on terms it deems appropriate, including a leaseback of all or a portion of the improvements constructed.

S.B. No. 2919, S.D. 2, also establishes the Library Facilities Fund and provides that all proceeds from the leases, permits, interest income generated from public library lands, and other revenues generated from the nonpermanent disposition of public library lands, including facilities, shall be deposited into the fund. The measure provides that all moneys in the Libraries Facilities Fund shall be for State Library programs. In addition, the measure makes unspecified appropriations of general funds for FY 19 for the pilot program and for the hiring of experts in land development issues to be expended by the Hawai'i State Public Library System.

With regards to S.B. No. 2919, S.D. 2, we offer the following comments. The measure is unclear if the Library Facilities Fund is being established as a special fund. The Department of Budget and Finance, as a matter of general policy, does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. In regards to S.B. No. 2919, S.D. 2, it is difficult to determine if the proposed (special) fund would be self-sustaining.

Chair Yamane, Vice-Chair Todd and Members of the Committee on Water & Land

Senate Bill (S.B.) 2919, S.D.2 establishes a pilot program to generate revenue through the leasing of public library lands, establishes a libraries facilities fund and makes an unspecified appropriation for the pilot program. The Hawaii State Public Library System (HSPLS) supports the intent of S.B. 2919 and provides the following comments.

In general, the HSPLS supports the intent to identify revenue generating programs to meet the mission of the public library system. The HSPLS notes, however, that it currently does not hold title to the lands under which the public libraries sit, nor that it has the expertise necessary to guide the HSPLS through a pilot program which involves the redevelopment, and leasing and management of library lands.

Although unspecified at this time, the HSPLS appreciates and supports provision for an appropriation which would to allow HSPLS to hire expertise to assist with land development issues.

My name is Diane Marshall. Today I am speaking on behalf of FEED THE STREET (FTS) and as a member of KPAC-KaLahui Political Action Committee.

I am STRONGLY OPPOSED to SB2919SD2.

This bill was suspiciously introduced early 2018...less than a month AFTER FEED THE STREETS' Holiday Meal Celebration, held on the back lawn of the Hawaii State Library.

FTS is a casual group of friends, farmers, non-profits, charities and organizations who support me through donations of food, clothing, blankets, pillows, personal hygiene items, toiletries, shoes, socks and other basic human needs to help or houseless, newly housed and soon to be housed friends.

Over 6 years ago, I started cooking for Honolulu's houseless population with FOOD NOT BOMBS at Thomas Square every Sunday evening.

I started FEED THE STREET to insure that at least 2 healthy vegetable filled meals per week were available to our hungry houselss friends. FTS has fed an average of 60 to 100+ people once every week since January 5th of 2017 on the lawn of the Hawaii State Library until the librarians kicked us out of the FRONT lawn because the "regular people" complained" about the homeless population EATING in the front. FEED THE STREET moved to the BACK lawn of the State Library and continued to feed our houseless until December 20th when we served almost 250 hungry friends, ALL from community DONATIONS in the pouring rain!

Aside from how SB2919SD2 directly affects FTS, this bill is another example of GENTRIFICATION and COMMERCIALIZATION of PUBLIC LANDS!

Thomas Square, Ala Moana, Kakaako, Honolulu, even OCCC lands are all being commercialized for the newly arrived rich living in the gentrified condos that MOST local families CAN NOT afford! BIKI-a City & County Non-profit has EXCLUSIVE, PERMANENT use of PUBLIC Parking spaces, PUBLIC sidewalks and PUBLIC park lands...

NOW you want to LEASE PUBLIC Library lands!

I strongly urge you to PLEASE consider the hard working-taxpaying PUBLIC when making these decisions.

WE should NOT have to PAY for rest and relaxation or access to PUBLIC spaces! The PUBLIC should NOT have to suffer ANY inconveniences so the state can make more MONEY. The library should NOT have to generate funds for their own maintenance.
