BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 448-8.5, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§448-8.5 Continuing education requirements. The board
- 4 shall adopt a program of continuing education for dentists and a
- 5 program of continuing education for dental hygienists. After
- 6 January 1, 2002, at the time of reregistration of license as a
- 7 dentist or dental hygienist, each licensee shall present to the
- 8 board evidence of compliance with the program of continuing
- 9 education applicable to their profession. In addition to any
- 10 other continuing education requirement adopted by the board,
- 11 after January 1, 2016, each licensee who is a dentist shall
- 12 present to the board evidence of having completed at least
- 13 [three] six hours of ethics training during the previous [year.]
- 14 two years for each biennial renewal period. Failure to
- 15 reregister and present evidence of compliance shall constitute a
- 16 forfeiture of license, which may be restored only upon written

- 1 application therefor and payment to the board of a restoration
- 2 fee."
- 3 SECTION 2. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 3. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect on July 1, 3000.

My name is Paul Guevara, D.M.D, M.D.S., and I am the Chairperson of the Board of Dental Examiners ("Board"). Thank you for the opportunity to testify in support of S.B. 2931, S.D. 1, H.D. 1, Relating to Dentistry, which is a companion to H.B. 2149, H.D. 1.

S.B. 2931, S.D. 1, H.D. 1 amends the ethics training requirement for dentists in the continuing education program to six hours of ethics training within the previous two years.

The Board fully supports this version of the measure, as it clarifies that the licensee must complete at least six hours of ethics training in the previous two-year biennial period to comply with the continuing education requirements for renewal.

Please note that companion bill H.B. 2149, H.D. 1 does not incorporate the same clarifying language. Therefore, the Board strongly recommends passage of S.B. 2931, S.D. 1, H.D. 1.
