#### In consideration of SENATE BILL 3027 SENATE DRAFT 1 RELATING TO THE KAHO`OLAWE ISLAND RESERVE COMMISSION

Senate Bill 3027 SD 1 appropriates funds for the Kaho`olawe Island Reserve Commission to restore, preserve and determine the appropriate uses of Kaho`olawe Island, and to fund one full-time equivalent (1.00 FTE) permanent position for the Kaho`olawe Island Reserve Commission. The Kaho`olawe Island Reserve Commission (KIRC) strongly supports this position.

In the State's FY18/FY19 approved biennium budget, Act 49 SLH 2017, KIRC was authorized 15 temporary positions and \$1,065,147 (FY18) and \$1,097,047 (FY19) in general funds for the management and restoration of the Kaho`olawe Island Reserve. Of these funds, \$883,647 is set aside each year for Personal Services. The remaining balance is allocated for \$93,000 each year for current lease payments for the KIRC's Wailuku office and \$88,500 (FY18) and \$120,000 (FY19) for Maui-based cost such as office and commission operation expenses and travel.

The additional funding is necessary to support volunteers, contractors and KIRC staff while on Kaho`olawe. This includes on-island housing, transportation, repair and maintenance of our buildings and infrastructure and safety equipment and supplies. Additionally, the funds are necessary to support the operations, repair and maintenance of the KIRC's landing craft, which is the primary means of transporting people, supplies and equipment to Kaho`olawe.

Due to the vacancy of the KIRC Cultural Resource Project Coordinator position in 2016, the KIRC was not able to include this position with those authorized in Act 49. This position is necessary to review and coordinate the various request to use the Kaho`olawe Island Reserve for Native Hawaiian cultural practices; conduct regular surveys and archaeological preservation of the island's 612 archaeological sites and 2,063 features; and to oversee the KIRC's Kaho`olawe Island Burial Council and island-wide National Historical Register status.

This funding is necessary for the KIRC to effectively meet the unique challenges of restoring, preserving and managing the appropriate, safe uses of the Reserve for the people of Hawai`i. Funding will enable the continuation of innovative KIRC land and ocean restoration programs for the Kaho`olawe Island Reserve and entrust a unique and critical opportunity to introduce, encourage and develop the next generation of land, ocean and cultural resource managers through an integrated *mauka* to *makai* volunteer program. Through immersive, hands-on experiences within a cooperative natural and cultural resource management system, these opportunities incorporate both traditional indigenous practices and modern scientific methods.

#### **TESTIMONY IN OPPOSITION**

Please note that the committee report from WTL incorrectly stated that my testimony was in support — my testimony to WTL was in opposition, and what's below is an exact copy of it.

This bill proposes to transfer 600,000 taxpayer dollars to the Department of Land and Natural Resources to provide funding for

specified programs of the Kaho'olawe Island Reserve Commission for fiscal year 2018-2019, plus an additional \$53,864 for one FTE staff position.

Please do not place this burden on the taxpayers of the State of Hawaii.

Let OHA pay all costs associated with the rehabilitation of Kaho'olawe -- an island which this legislature and OHA both believe will be handed over in the near future to the Hawaiian tribe which OHA has been working so hard to create for at least 18 years.

As the language of this bill points out, "Pursuant to section 6K-9, Hawaii Revised Statutes, the management and control of the Kaho'olawe island reserve will be transferred to a sovereign Native Hawaiian entity upon its recognition by the state and federal governments. This event is anticipated to occur within the timeframe of the 2026 strategic plan."

In Act 195 (2011) this legislature set in motion a process now underway to create a Hawaiian tribe. The U.S. Department of Interior recently proclaimed a regulation whereby that tribe can get federal recognition -- the final rule 43CFR50 proclaimed by the U.S. Department of Interior by publication in the Federal Register on October 14, 2016. Both Act 195 and the Department of Interior regulation insist that the Hawaiian tribe must be exclusively for Native Hawaiians, and that anyone lacking a drop of the magic blood must be ruthlessly excluded.

According to OHA trustee Lei Ahu Isa, OHA has used approximately \$33 Million of state government money over the years to lobby for federal recognition of a Hawaiian tribe either through the Akaka bill or through advertising and racial registration programs both in Hawaii and on the mainland. OHA provided the entire funding for an election of delegates and a monthlong meeting in 2006 which produced a proposed constitution for the tribe. OHA has repeatedly pledged that

when a Hawaiian tribe has achieved federal recognition, OHA will transfer all its assets to the tribe.

If the tribe is successful in creating itself and getting federal recognition, section 6K-9 of the Hawaii Revised Statutes guarantees that the island of Kaho'olawe will immediately be ripped away from the State of Hawaii and handed over to the Hawaiian tribe, to which people with no native blood are forbidden to belong.

This legislature simply must not confiscate tax dollars from 80% of Hawaii's people for a project which they will be racially excluded from.

It would be foolish and immoral for the State of Hawaii to spend taxpayer dollars collected from 100% of Hawaii's people of all races to pay for upgrades to an island which is expected to be removed from the State of Hawaii and handed over to a sovereign "nation" [tribe] restricted by law to one racial group whose people are perhaps 20% of Hawaii's people, most of whom will probably not even join the tribe. Once the tribe has been created there will be negotiations between the State of Hawaii vs. the tribe to decide how much additional land and money the State will give to the tribe. The State should not give away resources before the negotiations even begin.

OHA's most recent annual report (2016) shows that OHA has total assets of more than \$600 million. And it continues getting more payments of state government money (ceded land revenues plus legislative appropriations) every year, including a bill in this year's legislature demanding \$35 million per year from ceded land revenues.

Enough already! OHA can easily afford funding for Kaho'olawe. Let OHA pay whatever money it wishes to pay to KIRC to rehabilitate Kaho'olawe -- an island which this legislature and OHA both believe will be handed over in the near future to the Hawaiian tribe which OHA is working so hard to create.

To the Honorable Donovan M. Dela Cruz, Chair; the Honorable Gilbert S.C. Keith-Agaran, Vice-Chair, and Members of the Committee on Ways and Means:

Good afternoon. My name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on Senate Bill No. 2977 SD1, regarding the Hawaii Climate Change Mitigation and Adaptation Commission being instructed to assess the effects of tourism on climate change and publish a report on its findings.

The OCC Legislative Priorities Committee is in favor of Senate Bill No. 2977 SD1 and support its passage as about one-third of greenhouse gas emissions in Hawaii come from aviation and marine transportation, much of which is driven by visitors.

Senate Bill No. 2977 SD1, is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it instructs the Hawaii Climate Change Mitigation and Adaptation Commission to assess the effects of tourism on climate change and publish a report on its findings.

Specifically, the DPH Platform provides that "[w]e know that climate change is a real threat to our islands and the world. We strongly urge candidates and elected officials to take immediate action to mitigate and adapt to the consequences of climate change. This includes funding adaptation measures including coastal retreat, effective participation of indigenous peoples in climate change governance, and recognition that indigenous, local, and traditional ecological knowledge is key in climate change adaptation solutions." (Platform of the DPH, P. 8, Lines 435-439 (2016)).

We need to give priority to the development of "green" sustainable industries and businesses. We need financial literacy and asset building programs to strengthen our 'ohana. Green commerce includes biodegradable or recycling packaging. We need to pursue relationships with the information technology industry. We need to invest in world-class higher education to stimulate our economic resources. We need to reduce our dependence on tourism, real estate development, and military. A diversified economy will help to create diversified jobs." (Platform of the DPH, P. 2, Lines 68-73, (2016)).

Given that Senate Bill No. 2977 SD1 instructs the Hawaii Climate Change Mitigation and Adaptation Commission to assess the effects of tourism on climate change and publish a report on its findings, it is the position of the OCC Legislative Priorities Committee to support this measure.

Aloha Chair Dela Cruz, Vice-Chair Keith-Agaran and members of the Committee on Ways and Means. First, Mahalo nui for the 2018-2019 funding for the Kaho`olawe Island Reserve Commission (KIRC).

Mahalo for the opportunity to testify in full support of SB3027 SD1 which will provide additional funding for island operations. Testimony over the years has stated that the Reserve serves as a repository for the rich natural, cultural and historical resources, therefore, the restoration and preservation of these resources are important to all the people of Hawaii. And as modern society dictates, to accomplish that mission bestowed on the State of Hawaii as the owner of this land, requires money. The KIRC is in its second fiscal year of its *Six-Year Financial and Work Plan,* submitted to the 2015 State Legislature. In FY2017, KIRC received \$1,065,000 of the projected \$2,185,000 needed to operate in 2018, a difference of \$1.1M. It has been a challenge to cut operational costs and raise funds to make up the difference which trickles down to affect the work that was already completed. Lack of maintenance affects the survival rate of the plants in the ground, facilities, infrastructure, and the list goes on.
