Re: S.B. 3029, Relating to Taxation

The Department of Taxation (Department) offers the following comments on S.B. 3029 for your consideration.

S.B. 3029 amends individual income tax brackets and rates. The bill applies to taxable years beginning after December 31, 2017.

Specifically, S.B. 3029 **eliminates** individual income taxes for taxpayers with taxable income of:

- \$3,300 and less for single filers,
- \$4,800 and less for head of household filers, and
- \$6,600 and less for joint filers.

S.B. 3029 also **reduces** individual income taxes for taxpayers with taxable income of:

- \$3,301 to \$14,400 for single filers,
- \$4,801 to \$21,600 for head of household filers, and
- \$6,601 to \$28,800 for joint filers.

S.B. 3029 **does not change** individual income taxes for taxpayers with taxable income of:

- Over \$14,400 for single filers,
- Over \$21,600 for head of household filers, and
- Over \$28,800 for joint filers.

The Department respectfully requests that the changes to individual income tax brackets and rates be made applicable to taxable years beginning after December 31, 2018. The Department is in the process of implementing individual income tax into its new computer system and additional time will allow the Department to properly implement the changes to individual income tax brackets and rates.

Dear Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Committee:

Thank you for the opportunity to testify in STRONG SUPPORT of **SB 3029**, which would eliminate state income tax for many taxpayers living below the poverty level.

We are one of only fifteen states that actually tax people further into poverty. While we tax the income of those in poverty in Hawai'i, most other states either provide a refund or require no payment. This bill would eliminate state income tax liability for many of those living in poverty in Hawai'i.

According to the Institute for Taxation and Economic Policy, Hawai'i places the second highest tax burden in the country on low-income families. Households in the bottom fifth of the income spectrum pay over 13 percent of their income in state and local taxes, while those in the top fifth pay 8 percent or less.

On top of their heavy tax burden, families in poverty in our state also face the highest cost of living in the nation. It is obvious that this imbalance is a contributing factor in our state's homelessness crisis. Eliminating state income tax for those households is one basic way to help them pay their bills and stay in their homes.

Chair Committee DELA CRUZ, Vice-Chair KEITH-AGARAN and Committee Members:

The League of Women Voters of Hawaii supports SB3029, that eliminates state income tax on the very lowest incomes, and decreases the amount of tax on other very low incomes, while retaining the current rates on other incomes. We add a comment on the level at which income is exempt from taxation.

The preamble to SB3029 lays out the strong case for eliminating income taxes for very low incomes. The Federal Poverty Guideline for Hawaii for 2017, for a family of 4 people, was \$28,290 (\$2,358/month). We can hardly imagine the challenges of managing one's life at these income levels. But many of Hawaii's residents face these daily challenges. For example, *The State of America's Children*, published by the Children's Defense Fund, reports that not only do *30,907* children in Hawaii under 18 years old live in these poor families, but *15,689* of them live in families with *half or less* of the poverty level incomes.

It seems cruel to take from these struggling families the taxes they are required to pay by current Hawaii law. SB3029 decreases the taxes taken from extremely poor individuals and households, eliminating taxes on the drastically poor. Hawaii would then move in the direction of the 35 states which do not tax incomes at or below the poverty level.

We note however that the exempt taxable income level in SB3029 is far lower than the 2017 or 2018 poverty level for Hawaii. We fail to find in the preamble or elsewhere in SB3029 an explanation of how the bill's drafters arrived at the stated exemption level. We would appreciate understanding the rationale for the bill's exemption level.

Aloha Chair Dela Cruz, Vice Chair Keith-Agaran and members of the Senate Ways & Means Committee,

The Young Progressives Demanding Action – Hawai'i, representing nearly 600 registered members, **strongly supports** SB3029 to eliminate state income tax for those at or below the poverty level.

This is a socioeconomic justice issue that gets at the heart of the tragic trend in our state of local families being priced out of Hawai'i. Working families here must contend with the highest cost of living in the nation, keeping the promise of a middle class future with upward mobility, financial flexibility and and future security out of reach for many. Many others choose to leave their home. Alleviating the tax burden on the lowest bracket—those at or below the poverty level—not only provides these struggling, local families with an opportunity to remain in Hawaii and hope for a middle class future, it creates a potential for economic activity while costing the state very little in lost tax revenue.

The Department of Taxation estimates that the total tax liability for residents with income under \$10,000 is just about \$3.5 million. That amount is probably higher than what the bill would actually cost, but probably the closest we can get with publicly available information. Additionally, Hawai'i is actually in the minority of states that tax people further into poverty: Most other states either provide a refund or require no payment at all.

We see this bill as a first step to combating poverty in our state. Eliminating state income tax liability for workers in the lowest tax bracket—which is actually well below the poverty line (\$6,600 for couples, \$4,800 for HOH, \$3,300 for singles) will help, but more must be done. We encourage this committee and the entire legislature to continue working toward creating a tax system that is designed to level the playing field and create opportunities for the least fortunate among us to achieve the so-called American Dream, not one that is designed to further stratify our society into an economic caste system that concentrates wealth at the top and denies the majority of people a life of opportunity.
