#### TESTIMONY ON S.B. NO. 36, S.D. 1, RELATING TO CONSUMER PROTECTION.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

The Department of Commerce and Consumer Affairs ("Department") appreciates the opportunity to testify on S.B. 36, S.D. 1, Relating to Consumer Protection. My name is Ji Sook "Lisa" Kim, and I am the Administrator of the Department's Cable Television Division. The Department supports this bill and requests the below amendment.

This bill requires the Department to regulate all channel designations and relocation of public, educational, and governmental ("PEG") access channels and allows cable operators to relocate and change the designation of PEG access channels only if certain conditions are met.

The Department strongly supports and fully acknowledges the public benefits of PEG access programming. PEG access programing promotes, among other things, civic participation through government cablecasts, which allow viewers to remain informed of issues affecting our local communities throughout the State, even if time and distance prevents them from attending public hearings and functions. PEG access programming also provides valuable information to viewers and serves as a vehicle to

connect Hawaii's unique communities through the discussion and coverage of cultural matters and events.

It is important to note, however, that federal laws bestow limited power to local franchising authorities ("LFAs") (i.e., the Department on behalf of Hawaii) regarding the regulation of cable services. The federal rules explicitly state that LFAs may not impose requirements on cable operators regarding the provision or content of cable services. With respect to channel assignments, while the federal rules expressly permit LFAs to require cable operators to provide 30 days' advance written notice of any change, the federal rules do not confer any other authority over channel assignments. Thus, LFAs may be limited in asserting additional regulatory powers over the designation or relocation of PEG access channels.

As such, the Department is concerned conflicts of law may arise and pose enforceability issues. In addition, the Department has agreements and orders that follow Federal Communications Commission ("FCC") regulations regarding cable services, facilities, and equipment, which could be affected by conflicts of law.

Due to the above, the Department recommends this bill be amended to follow language that is present in the laws of California (Cal. Pub. Util. Code § 5870(b) (West 2018)) and Illinois (220 III. Comp. Stat. 5/21-601 (2017)) that address the designation or relocation of PEG access channels. Specifically, the phrase "unless prohibited by federal law" should be inserted into the bill at page 2, line 15 after "Notwithstanding any law to the contrary," to address any conflicts of law that may arise with passage of this measure. The Department also suggests that in conjunction with this bill, a resolution be sent to Hawaii's congressional delegation and the FCC that requests changes to current federal laws and/or regulations that expressly allow LFAs more discretion. This resolution would also clarify the regulation of cable operators and the provision of PEG access services.

Thank you for this opportunity to testify in **STRONG SUPPORT** OF SB36 SD1.

The purpose of this bill is to require the department of commerce and consumer affairs to regulate all channel designations and relocation of public, educational, and governmental access channels. It also allows cable operators to relocate or change the designation of public, educational, and governmental access channels only under certain conditions.

In a move that will effectively make local, public, non-commercial community television channels hard to watch and hard to find, Spectrum Cable has announced that it is moving Olelo from its current high traffic locations to what are essentially vacant slots. What this means is that you will turn to Channels 49, 53, 54 and 55 to get reliable neighborhood centric 2018 election coverage and you will not be able to find it. Research has proven that when channels are relocated like this in the absence of a well-funded comprehensive re-branding campaign, a significant audience is lost forever.

What Spectrum is doing defeats the purpose of why these non-commercial access channels were established. They were set up for no other purpose but to create <u>access</u> to cable television studios for people who would otherwise not have a voice and to encourage civic engagement by televising issues of public importance, providing in depth coverage of government meetings and making government more accessible to the masses.

Slamming these channels into the digital 180's will cause them to disappear from the newspaper TV grid and force subscribers to pay for special equipment to view. If this happens, fundamental access to Government will be curtailed.

This bill will allow the DCCA to control where, when, how, and if the cable company is allowed to move these channels on all islands.

I strongly urge you to pass SB36 SD1.

# In consideration of SB 36 SD1 Relating to Cable Communications

Chair Baker, and Vice-Chair Tokuda, and Members of the Committee.

Olelo Community Media respectfully offers its strong support of SB 36 SD1 Relating to Cable Communications.

SB 36 SD1 would require the Department of Commerce and Consumer Affairs (DCCA) to regulate public, education and government (PEG) access channel number designations on cable systems operated by cable service providers in the State.

We strongly support this bill as evidenced by the recent actions of Charter Communications to relocate PEG access channels on Oahu and subsequently on the neighbor islands. Charter's actions are arbitrary, capricious, unilateral and not in the best interest of the people of Hawaii. Charter has not offered any legitimate reason to relocate PEG access channels, other than to have commercial networks with multiple channels acquire an additional channel by removing PEG access channels from their current locations. PEG access channel locations that have been on the cable systems for decades. Channel locations that are well known to viewers, branded by our local community producers for their programs and for essential local government programming such as legislative hearings and sessions, county council meetings and hearings, and neighborhood board meetings. If these long standing programs are relocated, we will all need to start all over again. That is clearly impractical, costly and totally unnecessary.

Local community producers who on their own time without remuneration put their heart and soul into their programs as well as the government programs from the legislature, county councils, and neighborhood boards that provide open access and transparency to the public, can and will be lost without the protections afforded under SB 36 SD1.

As part of our testimony, together with written comments submitted to the Cable Advisory Committee meeting on February 2, 2018, I will offer the more than one hundred letters strongly opposing Charter's planned relocation of PEG access channels from community members, each of the four county mayors, state legislators, and county council members. Clearly, maintaining the current channel locations of PEG access channels is in the public interest.

Thank you Chair Baker and committee members for your support on this very important matter that preserves and fosters local community access programming for all of Hawaii.

am founder and managing director of a small community based theatre company called PlayBuilders of Hawaii Theater Company, whose mission is "to gather and share real stories that resonate with, empower, and connect individuals within the many rich and diverse communities in Hawaii." 'Olelo Community Media has been with us since our founding in 2011, video taping and airing our original plays which we have written with and for both geographic and special interest communities on 'Oahu. Some of the communities we have served include the geographic communities of Chinatown, Wahiawa, Waipahu, as well as Hawaii's homeless, LGBT, and Foster Youth communities. For all our projects, I have served as a community organizer; working with organizations such as the The Wahiawa Historic Society, Catholic Charities, Hawaii, Waipahu Community Coalition, Foster Care Training Committee, Leeward Community College, The Waianae Comprehensive Health Center, the Mele Program of Honolulu Community College, Nanakuli High and Intermediate School, and the Hawai'i State Department of Health.

When 'Olelo has taped our plays and televised them, the impact and reach of our plays have been amplified significantly. This empowers the community members of the often-marginalized communities we work to be heard, not only by our audiences who attend our plays, but to thousands of others living in Hawaii Nei.

By displacing 'Olelo and moving it to channels difficult to find, you are doing a huge disservice to our community. I am unsure why they could be allowed to do this. Isn't part of the reason Spectrum and companies like Spectrum are given cable rights because they agree to provide public access to the airwaves? Moving the channels to a place where it is impossible to find that access defies the spirit of that agreement. Personally, as a Spectrum customer, the easy access to 'Olelo is one of the reasons why my husband and I continue our cable subscription. And if they are allowed to do what they are planning, they will surely lose customers like me who realize that their are other options available to us for news and entertainment.

Spectrum's attempt to silence community media by displacing local programming

channels and imposing barriers to access these channels discriminates against community access organizations like PlayBuilders and is not pono. They may be allowed to do this in other states on the contenent, but because Hawai'i is different and more removed from the concerns of the mainland, Spectrum can and should leave our community access channels where they are – like Hawaiian Telcom, Oʻahu's other franchised cable operator, who keeps the 'ÅŒlelo channels on digital 49, 53, 54, and 55.

Our value and importance has increased, because we have focused on the core mission and values of providing hyper local events like: Hilo High School Graduation Live coverage, BIIF Boy's and Girl's Basketball Live Championship games, University of Hawaii Men's and Women's Live basketball games, BIIF Division 2 Boy's Championship Football game as a live event, TMT coverage as a live event for over 44 days, Local election night coverage, and many more community events to numerous to list here.

NLTV has and is working with Hawaii County Civil Defense on a Emergency Broadcast Channel. This endeavor allows the local Civil Defense administration to broadcast LIVE from their headquarters on channel 55 any time that they feel it is needed. This alone is another very important reason on why SB 36 SD is very crucial. When used properly and efficiently, our island residents can get important Civil Defense information from our channels. We have already launched this initiative in 2017, and moving our channels would only cause more confusion.

There is no reason for Spectrum to relocate any of our channels. We have voluntarily "given back" tremendous bandwidth in the move to a new digital migration from analog channels.

Aloha Chair Baker, Vice Chair Tokuda and Members of the Committee,

I am Myoung Oh, Director of State Government Affairs, here on behalf of Charter Communications in **opposition** to S.B. 36, S.D.1, which requests the Department of Commerce and Consumer Affairs to regulate all channel designations and relocation of public, educational, and governmental ("PEG") access channels and allows cable operators to relocate or change the designation of public, educational, and governmental access channels only under certain conditions.

Under federal law, the federal Cable Act, and the U.S. Constitution, the state cannot interfere in a business contract. Currently, channel placement is a negotiated provision within cable franchise agreements which pursuant to bilateral negotiation, as recently as 2016, has left discretion on channel location with the cable operator. DCCA and Charter negotiate license agreements balancing community interest--including current public access programming—among others. Channel location should be negotiated fairly between operators and regulators—not mandated by the state government

Federal courts have held that that cable franchises are contracts, <sup>1/</sup> and thus any unilateral action by the legislature to modify the business terms that are explicit and indisputably afforded Charter under its current franchise with respect to PEG channel placement would violate federal law and the Constitution. For these reasons, and because unilaterally changing the terms of a negotiated contract is inequitable, Charter respectfully opposes SB 35, SD1.

Cable franchises are contracts and should be interpreted in accordance with basic principles of contractual interpretation and applicable law. See, e.g. Denver Area Educ. Telecomm. Consortium v. FCC, 518 U.S. 727, 769 (1996) (Stevens, J., Concurring) (noting Court's consensus view that franchise agreements between cable operators and local franchising authorities are contracts); id. at 794, (Kennedy, J., Concurring) ("[a] franchise agreement is a contract"); Texas Cable & Telecomm. Ass'n v. Hudson, 265 Fed. Appx 210, 212 (5th Cir. 2008), cert. denied Sw. Bell Tel. v. Texas Cable & Telecomm. Ass'n, 555 U.S. 938 (2008) (characterizing franchise agreements between cable operators and municipalities as "long-term contracts"); Paragould Cablevision, Inc. v. City of Paragould, 930 (1931), 1314-15 (8th Cir. 1991) (franchise is a bargained-for contractual agreement), cert. denied 112 S. Ct. 430 (2d Cir. 1995) (treating franchise agreement as a contract and holding that provisions of such agreements that are inconsistent with the Cable Act are preempted by Federal law).





There is no rate change associated with the movement of these channels, nor any impact on the content or availability of PEG services.

#### **BACKGROUND**

Charter Communications is a dedicated community partner in Hawai'i. We currently have over 3,500 Wi-Fi hotspots deployed throughout the islands with a commitment to provide hundreds more in 2018. We employ 1,400 Hawai'i residents and contribute to Hawai'i's economy with over \$50 million in taxes.

We have also raised our base-level broadband speed to 200 Mbps for new customers and have launched Spectrum Internet Assist, our low-cost broadband program, for low-income families and seniors, which at 30 Mbps, will be the fastest program of its kind offered by any broadband provider, and we believe will have a tremendous positive impact on the communities we serve in Hawai'i. We also committed to improve service with by converting to an all-digital network.

## OVERVIEW OF CHARTER'S ALL-DIGITAL CONVERSION.

Since acquiring the cable systems in May of 2016, Charter has continued to make investments in its network to enhance the services we provide to our customers.

Spectrum is upgrading the cable television system to provide all-digital service, which will bring many benefits to our viewers with more HD channels, better video quality and faster broadband internet speeds to name a few. Spectrum's upgrade to 100 percent digital is a merger commitment and is a tremendous value for customers.

As part of the all-digital upgrade, consumers will receive:

- Better picture and sound;
- Over 70 new channels and increased On-Demand viewing options;
- Enhanced digital TV Guide and search capabilities;
- Improved service quality on digital boxes through two-way communication; and
- Faster Internet speeds with starting speeds of 200 Mbps.

Indeed, in anticipation of the all-digital transition and in light of the additional capacity available on our network, Charter has already increased the starting speed for new customer from 60 Mbps, to 100 Mbps, and now 200 Mbps in many of service areas in Hawaii. Additionally, Hawaii was the first market in which we launched our 940 Mbps Spectrum Internet Gig service, consistent with Hawaii's broadband objectives.

## PEG CHANNEL LINEUP CHANGES.

With the addition of 70 new channels, the line-up and locations of some channels will be moved simultaneously with the Charter's transition to all-digital technology. We recognize that change





can be unsettling, but we are confident that the enhanced Spectrum Guide will help viewers easily navigate the channel locations.

These changes are not limited to the PEG channels, however, Charter does intend to move the PEG Channels from their current positions, between 48 and 55, to new positions between 181 and 187.

However, despite these channel relocations, the PEG viewers will be able to locate and customize their remote control to easily access these channels. And, with the clustering of PEG and news channels together, 'Olelo and the other PEGs will likely get new viewers due to their new neighboring channels.

# Misconceptions About the PEG Channel Relocation.

Charter notes that, in response to this change, there has been a lot of mis-information being circulated regarding the impacts of this change. For the sake of clarity, we want to confirm that:

- Charter is not "slamming" the PEG Channels or trying to make them hard to find. The company has always supported PEG and has continued to do so since acquiring these systems in 2016. The reality is that these channel positions are comparable to those used by many major content providers. The PEG channels are:
  - O Lower than 70% of the channels including MTV and Nickelodeon.
  - Located right below popular sports networks like the NFL Network.
  - Easily located through the Channel guide like any other channel.
- Spectrum is not attempting to "silence" the PEG Channels. Nothing could be farther from the truth. As previously mentioned, many popular cable networks reside in the same general area on the channel lineup and after the all-digital transition, all PEG channels will be available as a part of Charter's Basic Service tier.
  - O Charter does not control the content on the PEG channels, but we believe that they will continue to provide an outlet for the community, provide coverage of government proceedings, and provide opportunities for independent media.
  - O Charter will continue to do its part by carrying this content on our cable system and making it available to all subscribers.
- Customers will not need special equipment to view the PEG Channels. Charter is confirming that, once the digital transition is completed, all subscribers, including those with DTAs, will have access to all PEG access channels that are currently available to them.
  - O Digital technology enables modern, interactive services that have become the industry standard.





- O Like other digital cable providers such as Hawaiian Telcom, digital cable technology does require equipment.
- o This applies to cable service generally and is not unique to the PEG Access channels.
- o Further, subscribers are entitled to receive up to two set-top boxes at no cost for up to two years depending on the current service level.

Spectrum has been very supportive of the PEG channels and generates millions of dollars each year to help fund their operations.

Because S.B. 36, S.D.1 is an attempt to unilaterally change the terms of a negotiated agreement, is inequitable, and violates federal law, Charter respectfully opposes. Cable franchise agreements are contracts negotiated by cable operators and DCCA taking into consideration community needs and requests for a variety of concessions, including PEG channel carriage requirements.

And for these reasons, we respectfully ask this committee to hold this measure.

Dear Sen. Baker, Sen. Tokuda and members of the Committee:

The migration of public access channels to higher digital numbers is both unnecessary and harmful to viewers, particularly to senior citizens. Many older cable subscribers will likely lose access to programming they depend upon should the present channels be replaced with digital high-numbered channels.

First, please note that Hawaiian Telcom is keeping channels as they are. No channel reassignment has been announced.

There is no pressing need to abandon the existing analog channels, and it is unlikely that Spectrum needs the small amount of bandwidth reclaimed by the transition. Changing the channel numbers is also unnecessary. It is important to keep the public access channels on the lowest tier of service, which is analog.

According to information I received on calling Spectrum, a digital adapter box can be mailed or picked up. It is required for each TV that does not now have a cable box. I was told that if the adapter is not installed at the time the 'Olelo channels are migrated, the TV screen will show either a scrambled image or be blank. I was told that the conversion in my area would take place by March 13 and would be complete for all locations on Oahu by the end of August, 2018. I have not yet been informed by Spectrum of the change—there is nothing on my bill, for example.

As a senior advocate, I am aware that many older people will not even have the tool necessary to unhook the cable and install the additional piece of equipment, which will likely also require electrical power. With this concern in mind, I asked the Spectrum customer representative if they would install the necessary hardware if a viewer could not do so on their own. The answer was yes, but Spectrum would charge a \$49.99 installation fee. For these viewers, Spectrum will be effectively requiring that they pay \$49.99 to continue to watch my program. Many will likely give up viewing instead.

A newspaper article indicated that Spectrum also intends to charge a monthly fee for the use of these adapter boxes in the future.

Although I have no current understanding of the conditions of the franchise arrangement now in force, I do wonder whether the fee is permitted under its terms.

I am the presenter of a program called Democracy Now which has aired on 'Olelo for almost exactly 14 years. The program airs daily and appears to have an audience in every demographic. In particular, senior citizens who are not "internet savvy" depend on the 'Olelo broadcast for the national news coverage it brings to Hawaii.

As a past president of Kokua Council, a senior advocacy organization of which I am still a board member, I am aware of the popularity of this program among elders because I have been thanked on many occasions for presenting the program on 'Olelo.

As part of its advocacy, Kokua Council encourages seniors and others to follow legislation at the State Capitol and to submit testimony on bills that affect them. Many, particularly those with mobility challenges, will watch sessions via Capitol TV on channels 49, 52, 53, or 54. The schedule of committee hearings and channels is posted on the state's capitol.gov website.



Seniors who cannot attend legislative hearings in person and who watch them on Capitol TV but do not have digital adapter boxes will effectively be charged \$49.99 if installation of these boxes should be required of them. Some will instead choose not to participate in the legislative process.

Let me re-emphasize: the channels can be left as they are. Spectrum's competitor is not moving the public access channels. The different numbers for different providers will be a source of confusion to all public access viewers on an ongoing basis.

The confusion, inconvenience, expense and potential disenfranchisement can be avoided by leaving the channels as they are.

Particularly for the Neighbor Islands there is leverage to require this since franchise agreements have not been completed. Keeping the Oahu channels as they are can be included as a condition in negotiations with Spectrum. However DCCA chooses to proceed, I do request that they work to keep the public access channels as they are now.

I strongly support SB36. I already voiced my concerns to Spectrum/DCCA. Here is my original letter

Charter Communications/Spectrum's decision to relocate Public, Education, and Government (PEG) channels on Oʻahu is not in the best interest of our community in Waipahu and is not in the best interest of serving cable subscribers in Hawaiʻi. Spectrum's forced 'Ōlelo channel change will pave the way for forced channel changes to all other PEGs in the State of Hawaiʻi - Nā Leo on Hawaiʻi County, Akakū on Maui County, and Hoʻike on Kauaʻi County. The harm that will be done to communities statewide, the loss in services and viewership, and the economic harm to each of the brands they have built over decades is of great concern. Local community voices and non-commercial programs will be replaced by paid programming and commercial channels.

'Ōlelo Community Media, O'ahu's non-profit PEG access provider, has been serving our communities for nearly 30 years. Like all other PEGs in the state, 'Ōlelo is committed to the principles of hyper local programming and freedom of speech. The channel numbers used by all of our PEGs have been established for 20-plus years. People know exactly where to find them. But Spectrum's forced channel relocation will abruptly change this, causing severe channel confusion that will begin in neighborhoods across O'ahu, and spread throughout the state. As Waipahu residents, we have yet to be notified of the change.

The hyper local programming 'Ōlelo provides includes City Council meetings, legislative hearings and sessions, community town halls, non-profit programs, and local stories produced by community media makers. In fact, 'Ōlelo provides the only local channel on O'ahu dedicated to government programs, an essential tool for ensuring government transparency. Channel 49 and Video On Demand Channel 50 enables the Hawai'i State Legislature, government agencies, and local officials to communicate timely messages, air public hearings, and capture government programs that inform and engage civic participation.

Spectrum's all-digital migration will also be an issue with our kūpuna who are less inclined to adopt new technology systems. (I/We) understand that although Spectrum provides installation support, it comes at a fee that low-income seniors cannot afford. Also, Spectrum's inconsistent information on the short and long-term costs of acquiring set-top boxes exacerbates the deep digital divide that still exists in our communities. The proposed changes will be an added financial burden on Hawai'i's working and fixed income families.

I strongly urge that all PEG channels remain at their current locations. Keep 'Ōlelo channels where they are!
