- 1 Fiscal Implications: None.
- 2 **Department Testimony:** The Department of Health (DOH) supports Senate Concurrent
- 3 Resolution (SCR) No. 0142 designating the first week of December as Cancer Screen Week to
- 4 urge the people of Hawaii to talk with their healthcare providers about appropriate screenings for
- 5 prevention and early detection of cancer. According to the Centers for Disease Control and
- 6 Prevention (CDC), screening regularly increases the probability of finding certain cancers early,
- when treatment is likely to be more effective. In the last year, approximately 600,000 people
- 8 were expected to die from cancer, yet many of those lives could have been saved through earlier
- 9 detection.<sup>2</sup> A public health initiative such as Cancer Screen Week will provide an opportunity to
- raise awareness and encourage people in the state to get recommended screenings.
- Screening is effective in identifying some types of cancers in early, often highly treatable
- stages including: breast cancer (using mammography); cervical cancer (using Pap alone or

- 1 combined Pap test and HPV test); and colorectal cancer (using stool-based testing,
- 2 sigmoidoscopy, or colonoscopy). Current screening rates for breast, cervical, and colorectal
- 3 cancer rates in Hawaii remain well-below the nationally recommended Healthy People 2020
- 4 targets. Increasing cancer screening rates for residents of Hawaii is a priority for both CDC
- 5 funded programs, the Breast and Cervical Cancer Control Program (BCCCP) and Hawaii
- 6 Comprehensive Cancer Control Program (HCCCP) in the DOH. The BCCCP provides critical
- 7 screening and early detection services to high risk, uninsured and underinsured, rarely or never
- 8 screened women between the ages of 50-64. The HCCCP convenes and supports the Hawaii
- 9 Comprehensive Cancer Coalition's efforts to reduce morbidity and mortality of breast, cervical,
- and colorectal cancer through screening and early detection. These priorities are in the Hawaii
- 11 State Cancer Plan 2016 2020. The DOH supports SCR0142 to designate the first week of
- 12 December as Cancer Screen Week.

PREVENTION AND EARLY DETECTION OF CANCER.

Chair Baker, Vice Chair Tokuda, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA **SUPPORTS** Senate Concurrent Resolution No. 142.

The resolution, as received by your Committee, would express the Legislature's intention that:

- (1) In 2018, and annually thereafter, the first week of December be designated as Cancer Screen Week in Hawaii; and
- (2) All citizens of Hawaii be encouraged to visit cancerscreenweek.org for cancer screening resources and talk to their healthcare providers about their risk factors for all cancer types, including breast, cervical, colon, lung, prostate, and skin cancers, and recommended screening options.

Federally Qualified Health Centers (FQHCs) provide desperately needed medical services at the frontlines in rural communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of health.

According to the National Cancer Institute, in 2017, an estimated 1,688,780 people in the United States were diagnosed with cancer, and 600,920 will die of cancer. Estimates of the premature deaths that could have been avoided through screening vary from 3% to 35%, depending on a variety of assumptions. Beyond the potential for avoiding death, screening may reduce cancer morbidity since treatment for earlier-stage cancers is often less aggressive than that for more advanced-stage cancers.

Community Health Centers serve on the front line providing desperately needed primary care for Hawaii's underprivileged communities. This testimony is presented as a private individual.

There is a saying in Japanese that says approximately, "The ocean is equally salty, no matter where you taste it." Although it is not literally true, it does remind me of the grief one feels when people you know and care about suffer, and sometimes die, with cancer. It is difficult for them, and also for those who can only play a supportive role.

Testimony from private individuals often recounts some of their personal experience. I have too many such experiences with people I care about to recount with this issue.

Efforts to prevent this group of illnesses can be very effective. Early detection is also effective. Both prevention and early detection are less costly, both emotionally and financially, then not making those efforts.

This resolution is so simple. It is socially responsible. If passed, it will take community cooperation to make it effective. That effort is worthwhile.
