#### SENATE CONCURRENT RESOLUTION S.C.R. 191

The Department of Customer Services (CSD) of the City and County of Honolulu would like to provide information regarding the current statewide organization license plate program.

CSD is the agency responsible to process the applications for the entire State. The proceeds from the number of license plates issued are forwarded to the organizations participating in this program on a quarterly basis.

In accordance with Section 249-9.3, Hawaii Revised Statutes (HRS), any not-for-profit organization recognized by the Internal Revenue Service under Section 501(c)(3) of the Internal Revenue Code are eligible to participate in this program. The organization must be headquartered in the State of Hawaii and provide a notarized statement that the organization will acquire at least 150 special number plates. In addition, the decal design is forwarded to the County Chiefs of Police for their review and approval.

Since the Windward Spouse Abuse Shelter met the criteria of Section 249-9.3, HRS, their application and decal design was approved on May 12, 2017. CSD accepts applications from not-for-profit organizations in all counties.
