In consideration of SENATE CONCURRENT RESOLUTION 39, SENATE DRAFT 1 AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT HEEIA, KOOLAUPOKO, OAHU, FOR THE EXISTING SEAWALL AND LANDSCAPED AREA AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON

Senate Concurrent Resolution 39, Senate Draft 1 requests authorization to issue a term, nonexclusive easement covering about a 1379 square foot, more or less, portion of state submerged lands identified as tax map key: (1) 4-6-001:seaward of 019, at Heeia, Koolaupoko, Oahu for the use, repair, and maintenance of an existing seawall and landscaped area constructed thereon, pursuant to Section 171-53, Hawaii Revised Statutes (HRS). The Department of Land and Natural Resources (Department) supports this concurrent resolution.

The unauthorized seawall was constructed on State land in 1978 by the previous owner, Richard Gessler. In 1981, Mr. Gessler worked with the Department to resolve the encroachment. However, in 1982 the Board of Land and Natural Resources (Board) denied the after-the-fact Conservation District Use Application (CDUA) without prejudice for further investigation of other possible land use violations. In 2007, Mr. Gessler sold the abutting property to Dr. Clayton Honbo, who in 2014 transferred the property to his company, Nanaina 'O Pali Ku, LLC. Subsequently, Dr. Honbo worked with the Department to resolve the encroachments. In 2017, the Board approved the after-the-fact CDUA. As required by Section 171-53, HRS, the Board may lease submerged lands "with the prior approval of the Governor and the prior authorization of the Legislature by concurrent resolution". At its meeting on December 8, 2017, under agenda item D-11, the Board approved the issuance of a term, non-exclusive easement for purposes stated above.

Finally, the Department notes that Senate Draft 1 describes the land area as "accreted". However, the Department has researched the matter and discovered that the State Surveyor, in a letter dated April 8, 1982, has previously determined this area to be filled land, not privately owned accreted land. Hence, the Department recommends that the word "accreted" be deleted from line 6. The grantee shall pay the State the fair market value of the easement as consideration for the use of public lands. The amount of consideration shall be determined by an independent appraisal.
