As the Commander of Rainbow Chapter 483, MOPH, we strongly support the passage of this resolution. Not only is this the oldest military decoration, established by GEN George Washington on August 7, 1782, but the only award that you can not be recommended for. It must be received for wounds or death from an armed enemy of the United States. Because of this, less than one percent of all military personnel that have served since WWI have received this honored decoration. It is also an award that no one wants, due to the pain and suffering required to earn it, but one that is worn proudly once received. There are over 3,000 recipients of this award in the State of Hawaii with the 100th Battalion, 442d Regiment, known as the "Purple Heart Battalion", for the most number of Purple Hearts earned by a unit of this size, in WWII. This unit is "Hawaii's Own". You will also be honoring their legacy with the passage of this resolution. It is the hope of the MOPH that each state will named a Purple Heart State and Hawaii is one of the few that has not been so named. Only Hawaii County has been named a Purple Heart County and it is also our hope that the City and County of Honolulu will follow their lead. As the Empire State Building and Niagara Falls are lighted in the color purple on August 7th of each year for Purple Heart Day, we hope our Capital Building will be lighted in the same way.
