To the Honorable Clarence K. Nishihara, Chair; the Honorable Glenn Wakai, Vice-Chair and Members of the Committee on Public Safety, Intergovernmental, and Military Affairs:

To the Honorable Lorraine R. Inouye, Chair; the Honorable Will Espero, Vice-Chair and Members of the Committee on Transportation and Energy:

Good afternoon. My name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") on Legislative Priorities of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on **SCR176 / SR 105** relating to Pedestrian Safety; Haleakala Highway; DOT; Highways Division; Kula Marketplace; and Kula Lodge.

The OCC on Legislative Priorities is in favor of **SCR176 / SR 105** and supports its passage.

SCR176 / SR 105 is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it requests that the Highways Division of the Department of Transportation

(1) assess the dangers of pedestrian use of the shoulder on the portion of Haleakala Highway between Upper Kim0 Drive and Ainakula Road; (2) examine the effectiveness of potential pedestrian safety countermeasures; and (3) submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2019.

The Platform of the DPH provides that "We believe in a government that will adequately, efficiently, courteously, openly, ethically and fairly administer to the needs of the people. (Platform of DPH, P.5, Line 443-448 (2016)).

"We seek to achieve energy sustainability based on renewable energy sources. We must encourage the use of clean alternative fuel sources to include our public

transportation systems. We must increase the use of public transit, telecommuting, car and vanpooling, ridesharing, biking, walking, and other forms of transportation thereby reducing traffic congestion and air pollution. We must also urgently develop the use of a variety of cost-effective energy providing systems, encourage transit-oriented development, and support tax incentives that encourage renewable energy initiatives." (Platform of DPH, P.8, Line 443-448 (2016)).

Given that **SCR176 / SR 105** requests that the Highways Division of the Department of Transportation (1) assess the dangers of pedestrian use of the shoulder on the portion of Haleakala Highway between Upper Kim0 Drive and Ainakula Road; (2) examine the effectiveness of potential pedestrian safety countermeasures; and (3) submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2019, it is the position of the OCC on Legislative Priorities to support this measure.

I wanted to voice my concerns for the safety of the pedestrians in my neighborhood. My family has lived on Ainakula Road for 42 years. I have seen our neighborhood change from a sleepy Wattle-forest landscape to a bustling densely-populated neighborhood. Many of us enjoy walking our neighborhood, and the loop from Ainakula Road to Haleakala Highway, and back through Lower Kimo Drive is almost a perfect 30- minute walk.

As a child, I used to walk from Ainakula Road to Upper Kimo Drive all by myself. Back then we did not have all that much traffic, and drivers used to obey the posted speed limit of 30 MPH. Now, as a mother, I would never send a child walking that stretch alone, for fear of their safety. I have personally been walking Haleakala Highway when a car speeding by at around 65 MPH nearly knocked my friend and I off the road. There is so much traffic now and while some drivers are courteous and move over to give pedestrians room to walk, others are not.

I am writing today to urge you to help keep our neighborhood safe. We desperately need a shoulder along Haleakala Highway from Ainakula Road to Lower Kimo Drive. Our pedestrians deserve a safe place to exercise, walk their dogs and children, and arrive safely at the bus stop.
