

My name is Dayton M. Nakanelua, State Director of the United Public Workers, AFSCME, Local 646, AFL-CIO. The UPW is the exclusive bargaining representative for approximately 12,000 public employees, which include blue collar, non-supervisory employees in Bargaining Unit 01 and institutional, health and correctional employees in Bargaining Unit 10, in the State of Hawaii and various counties. The UPW also represents about 1,500 members of the private sector.

The UPW **strongly supports** SR114 respectfully urging the Hawaii Congressional delegation to oppose any Right-to-Work legislation. This type of labor law leads to loss of wages in Right-to-Work states; it creates "free riders" on the backs of hard-working dues paying union members and produces more poverty in Right-to-Work states than others. The middle-class of America, that means most of us, is being threatened by laws reducing the rights of organized labor. The "Right-to-Work" means the right to work for less.

TESTIMONY FOR SENATE RESOLUTION 114, URGING HAWAI'I'S CONGRESSIONAL DELEGATION TO OPPOSE ANY PROPOSED FEDERAL RIGHT-TO-WORK LEGISLATION

Honorable Chair Tokuda and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 400 members. On behalf of our members, we offer this testimony in support of Senate Resolution 114, urging Hawai'i's congressional delegation to oppose any proposed federal right-to-work legislation.

On February 1, 2017, Representative Steve King and Representative Joe Wilson introduced federal legislation to enact a national right-to-work law that would amend the National Labor Relations Act of 1935 and Railway Labor Act of 1926 to bar the inclusion of union security clauses in collective bargaining agreements. At the same time, unions are facing an unprecedented assault from the Trump Administration and pending U.S. Supreme Court decision in *Janus v. AFSCME*.

Right-to-work legislation would be devastating for working families. According to the Economic Policy Institute, wages are 16 percent lower in right-to-work states. Moreover, according to the Henry J. Kaiser Family Foundation, individuals under the age of 65 in right-to-work states are 38 percent more likely to be uninsured. Finally, the U.S. Census Bureau notes that overall poverty and child poverty rates are higher in states with right-to-work legislation, further evincing the damage that would be wrought be the passage of a national right-to-work law.
