

Public Purpose:

Waikiki Health's request for FY 2020 State Grant in Aid funding aims to support two capital improvements at our Makahiki Medical & Dental Clinic. These facility upgrades will serve our community by **improving the patient experience** and **increasing access to care**.

A/C System Replacement: This upgrade with serve our current and future patients by providing reliably temperature-controlled and comfortable air conditioned environments in our waiting areas, exam rooms and other patient service areas. Front entrance re-design: This upgrade will provide a more easily accessible facility and remove what could be a barrier to care for some individuals. Although our current entrance doors are ADA-compliant, our goal is to install a new power-assisted front door entry system so that patients in wheelchairs, on crutches or with other mobility challenges can readily gain access to our clinic without requiring assistance.

II. Background and Summary

1. Brief description of the applicant's background

Waikiki Health, which is beginning its 52th year of service to the community, is Hawaii's oldest Federally Qualified Health Center (FQHC), and is recognized as assisting the highest-risk populations among all Hawaii FQHC. In CY 2017, Waikiki Health provided 53,404 primary care visits to 9,905 unduplicated patients; of these 9,905 patients, 50% had Med-QUEST coverage, 13% had Medicare, 14% were uninsured, and 14% were homeless.

Service sites include: Ohua Clinic and Education & Counseling Services annex in Waikiki; Makahiki Medical & Dental Clinic in McCully-Moiliili; PATH Clinic in Kaimuki; Youth Outreach (YO!) in Waikiki, our drop-in center and clinic serving homeless youth; and Next Step Shelter in Kakaako. HEIS (HIV/Hepatitis C Early Intervention Services) helps clients at partner agencies' substance abuse treatment facilities reduce their HIV and Hepatitis C health risks, and promotes tobacco cessation. Care-A-Van medical/behavioral health outreach teams assist clients at programs operated by Salvation Army and Hina Mauka; and provide services at prison furlough sites. Medical-Legal Partnership Hawaii, a project of Waikiki Health & UH-Manoa's School of Law, offers free legal help to our patients at Ohua Clinic.

Our "ED (Emergency Department) Diversion Plan" works to reduce over-crowding at hospital EDs. Queen's and Straub staff partner with our RN Care Coordinators to encourage our patients who visit EDs with non-emergency concerns to return to our clinics for appropriate care. Waikiki Health's **Pu'uhonua Prison Program** helps offenders in Oahu correctional facilities both pre- and post-release to facilitate their re-entry to the community and avoid recidivism.

Waikiki Health's Makahiki Medical & Dental Clinic – the focus of our FY 2020 Grant in Aid request – created a new access point for providing health care to the community when it opened in 2014. The facility, located in McCully-Moiliili, was extensively renovated in 2017. We more than doubled the number of medical exam rooms to 19, established a Pharmacy, and introduced other services. Waikiki Health is requesting FY 2020 Grant in Aid funding to support two essential Makahiki Clinic facility upgrades: replacement of the aging A/C system and a front-entrance re-design to improve access. Support for these Capital projects will ensure the clinic continues to provide an environment conducive to treating thousands of patients served annually at that facility, while also reducing energy use and decreasing costs.

3. The public purpose and need to be served

Waikiki Health's request for FY 2020 Grant in Aid funding to support capital improvements at our Makahiki Medical & Dental Clinic, will serve our current and future patients in the community by **improving the patient experience** and **increasing access to care.**

A/C System Replacement: This upgrade with serve our current and future patients by providing reliably temperature-controlled and comfortable air conditioned environments in our waiting areas, exam rooms and other service areas. Front entrance re-design: This upgrade will provide a more easily accessible facility and remove what could be a barrier to care for some individuals. (Most patients are able to simply pull open our front door, but this is not possible for everyone.)

With support from FY 2020 Grant in Aid funding, these upgrades will ensure that our services "begin at the curb": Our patients – especially those in wheelchairs, on crutches, or with other mobility challenges – will be able to enter our front doors and check-in for their appointments more quickly and easily. Once inside, the temperature in Makahiki Clinic's waiting areas, exam rooms and other patient service offices – after our current A/C system is replaced – will provide a consistently comfortable environment. As 14% of our agency's patients are homeless, many living outdoors, those who receive services at our Makahiki Clinic will welcome our improved A/C system, and opportunity to visit the clinic for appointments, especially on hot or rainy days.

Through these upgrades, our facility's physical environment will improve our service delivery to patients and be better aligned with the high level of health services we provide. Reduced costs resulting from Waikiki Health's Makahiki Clinic facility upgrades will enable the health center to re-direct the savings toward expanded patient services. It will mean that more members of our island community will be assisted in receiving essential and ongoing primary and preventive medical care and related social support to improve their health and quality of life.

4. Target population to be served

All Makahiki Clinic patients will be favorably impacted by these planned upgrades. Makahiki Clinic is the health center's largest primary care clinic. In 2017, the clinic provided a total of 20,750 medical visits to 7,547 patients, and 5,089 dental visits to 1,144 dental patients. Everyone who walks through the doors of the clinic will benefit from these needed infrastructure upgrades.

5. Geographic coverage

Makahiki Medical & Dental Clinic is located at 935 Makahiki Way in McCully-Moiliili, off S. King Street, and between the local library and Old Stadium Park. Makahiki Clinic serves patients who live in the neighborhood, including many homeless individuals; patients and clients referred by our other program sites and Next Step Shelter; and also includes a high number of walk-ins. Anyone is welcome, regardless of insurance status, gender, sex, race/ethnicity, ability to pay or any other consideration.

Vendors' bids for two upgrades – A/C System Replacement and Front Door Re-design – are being accepted and reviewed by Jay Tamashiro, Waikiki Health's Director of Operations, and are being submitted to the health center's CEO for consideration. Referrals to contractors and other assistance is being provided by Hawaii Energy's "EmPOWER Hawai'i Project" team.

Following project completion, Jay Tamashiro and Waikiki Health's CEO will conduct walkthroughs with contractors to ensure that the assigned work was completed satisfactorily. This important project will greatly assist Waikiki Health's Makahiki Clinic in delivering services to patients in as supportive and accessible an environment as possible. 4. Waikiki Health carried out a \$1.4 million Capital Campaign (including support from 2013 City Grant in Aid funds and 2014 State CDBG funds) to establish Makahiki Clinic in 2014, as our Ohua Clinic in Waikiki could not accommodate our continually growing patient population. Establishing Makahiki Clinic also provided available space to house our first Dental Clinic with 7 dental operatories.

In 2017, just a few short years later, Makahiki Clinic needed extensive renovations to serve our increasing patient base. Makahiki Clinic more than doubled its number of medical exam rooms from 8 to 19; along with opening an on-site Pharmacy and introducing other patient services.

This renovation project transformed Makahiki Clinic's entire third floor into additional patient service areas; previously, the space had housed most of the agency's administrative offices, which were relocated to a new address at S. King Street at McCully.



II. Background and Summary

1. Brief description of the applicant's background

Waikiki Health, which is beginning its 52th year of service to the community, is Hawaii's oldest Federally Qualified Health Center (FQHC), and is recognized as assisting the highest-risk populations among all Hawaii FQHC. The health center is Hawaii's only recipient of Federal Ryan White funding for HIV/Early Intervention Services; and 330(h) Homeless Outreach funding, targeting patients experiencing homelessness, often with a dual diagnosis of mental illness and substance use challenges. In CY 2017, Waikiki Health provided 53,404 primary care visits to 9,905 unduplicated patients; of these 9,905 patients, 50% had Med-QUEST coverage, 13% had Medicare, 14% were uninsured, and 14% were homeless. Waikiki Health employs a staff of 173, including executive and leadership positions, medical and social service professionals, clinical support, case managers, care coordinators, and administrative functions.

Waikiki Health's program sites include the **Ohua Clinic** and **Education & Counseling Services** annex in Waikiki; **Makahiki Medical & Dental Clinic** in McCully-Moiliili; **PATH Clinic** in Kaimuki, targeting pregnant and parenting women with addiction challenges; **Youth Outreach (YO!)** in Waikiki, our drop-in center and clinic serving homeless youth; and **Next Step Shelter** in Kakaako. **HEIS** (HIV/Hepatitis C Early Intervention Services), a community outreach program, helps clients reduce their HIV and Hepatitis C health risks, and promotes tobacco cessation, serving clients at partner agencies' substance abuse treatment facilities.

Care-A-Van medical/behavioral health outreach teams assist clients at programs operated by Salvation Army and Hina Mauka, and provide services at furlough sites. **Medical-Legal Partnership Hawaii**, a project of Waikiki Health & UH-Manoa's School of Law, offers free legal help to our patients. Our "**ED** (**Emergency Department**) **Diversion Plan**" works to reduce over-crowding at hospital EDs. Queen's and Straub staff partner with our RN Care Coordinators to refer our patients who visit their EDs with non-emergency concerns to our clinics for care.

Waikiki Health's Pu'uhonua Prison Program – the focus of our Grant in Aid request –

assists men and women incarcerated in Oahu correctional facilities both pre- and post-release to facilitate re-entry to the community, avert recidivism, reduce the prison population and decrease costs. Pu'uhonua's pilot received funding from the Chamber of Commerce Hawaii Public Health Fund; and a 2-year HMSA grant (Oct. 1, 2017 – Sept. 30, 2019) has supported further expansion.

4. Target population to be served

Waikiki Health's Pu'uhonua Prison Program addresses the health and related social service needs of men and women incarcerated in Oahu pre- and post-release. While Pu'uhonua is presented in a cultural framework – targeting Native Hawaiians and Pacific Islanders who are disproportionately represented in Oahu correctional facilities and prisons – it is designed to engage, encourage and benefit anyone transitioning back into society.

At **39%** (U. S. Census 2010, Hawaii only), the in-state total of **4,098** inmates included: Native Hawaiians and Pacific Islanders (**1,615**); Caucasian (412); Hispanic (415); Black (1,032); American Indian/Alaska Native (624).

Research has shown that social factors (educational attainment, employment status, economic status) are related to incarceration. Native Hawaiians are less likely to have earned a Bachelor's degree and have higher poverty rates than other populations. In addition, interviews with *Pa`ahao* (formerly incarcerated or currently incarcerated people), point to the **strength of Hawaiian culture** as the foundation for helping Native Hawaiians avoid recidivism.

5. Geographic coverage

Pu'uhonua serves offenders incarcerated in **O'ahu Community Correctional Center**, **Halawa Correctional Facility**; and the **Federal Detention Center**, **Honolulu**. Other individuals (incarcerated in the Women's Community Correctional Center and **Waiawa Community Correctional Center**) are served by Pu'uhonua's network of community partners.

III. Service Summary and Outcomes

1. Describe the scope of work, tasks and responsibilities

Waikiki Health's **Pu`uhonua Prison Program** was developed and implemented by Francine Dudoit-Tagupa, RN, Director of Native Hawaiian Healing and Pu`uhonua Director. The Program **reduces barriers** to accessing services and helps participants **obtain information and tools** to navigate through the challenges of re-entering the community.

Scope of Work:

Research by the Paroling Authority identifies three essentials that are needed to significantly reduce recidivism, all of which are addressed by Pu'uhonua: a Livable Wage, Safe Place to Live, and Healthy Relationships. Our program data has confirmed these findings as well. Of the 970 offenders that we served from October 1, 2017 through September 30, 2018, only 94 (less than 10%) have re-entered correctional facilities, and none for a new crime, only due to parole or probation violations.

Correctional Center (including Annex 1, Annex 2, Makai, Mauka, Laumaka, and Women's section); Halawa Correctional Facility; and the Federal Detention Center, Honolulu.

Ms. Dudoit-Tagupa encourages and guides Pu'uhonua participants in creating their personal "Going Home Plan for Success," describing what they hope to accomplish post-release. Ms. Dudoit-Tagupa also offers participants the healing modality of *ho'oponopono*, called "the Hawaiian Secret of Forgiveness," helping the individual let go of resentment, and become "right" with himself or herself and others. Ms. Dudoit-Tagupa is planning to increase her speaking engagements to inform more organizations about how the Pu'uhonua Program is beneficial for offenders, their families, the prison system, and wider community.

- **Pu`uhonua Eligibility Specialist: Cheryl Moreno** Ms. Moreno assists incarcerated men and women in filling out applications for Med-Quest, SNAP, and other benefits. Post-release, Cheryl helps them activate their benefits, sets up a mailing address for them to receive mail at our Ohua Clinic, Makahiki Clinic or Next Step Shelter, and addresses other needs.
- **Pu`uhonua Program Assistant:** Kanoe Kanahele Ms. Kanahele records and tracks Pu`uhonua participants' progress in receiving services with Pu`uhonua staff's assistance. Kanoe received training to process Med-QUEST and other applications for benefits.
- **Proposed New Hire:** An additional 1.0 FTE Eligibility Specialist is needed to help Pu`uhonua reach and assist more offenders pre- and post-release.
- Outreach to Furlough Sites: Waikiki Health medical/behavioral health staff Once each month, a Waikiki Health Physician, Licensed Clinical Social Worker and Medical Assistant, travel in a medically-equipped van to furlough sites to assist furloughed offenders. Providing TB tests and physical exams on-site at correctional facilities facilitates the furloughed individuals securing employment, and gaining access to housing when released.

Community Partners:

- Volincore Clearance Pu`uhonua Re-certified its Clearance for Volincore with the Department of Public Safety, enabling Pu`uhonua staff to meet with incarcerated individuals studying yoga. The discipline of yoga can lead to fundamental change in a person, including a deep sense of community, and transformation on the levels of body, mind, and spirit.
- Collaborating Agencies and Individuals: Barbara Gatewood, Prison Chaplain (Transforming Lives Prison Ministry); First L.A.P. (Life After Prison); Chaminade University School of Nursing, assisting women at the Women's Community Correctional Center); Young Women's Christian Association of O`ahu (YWCA O`ahu Fernhurst Transitional Housing Program); Makiki Christian Church. In addition, Pu`uhonua staff are working with the Department of Public Safety, Paroling Authority and Probation Office, along with United Self-Help, to coordinate the provision of services. Legal advocacy is offered free of charge to our patients, including Pu`uhonua participants post-release, through our Waikiki Health & UH-Manoa School of Law Medical-Legal Partnership Hawaii.

3. Describe the quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results

Waikiki Health's Pu'uhonua Program Assistant will record and track all services provided to Pu'uhonua participants and results achieved. For example: Data will indicate those who (1) move into "clean and sober" facilities or shelters, and as a result avoid homelessness; (2) enroll into Med-Quest, SNAP and other programs; (3) receive TB tests, physical exams and other services at furlough sites; (4) utilize our "List of Employers" to apply for work with firms that have agreed to hire and train former offenders; (5) choose Waikiki Health as their "medical home"; (6) receive free legal assistance through our Medical-Legal Partnership Hawaii; (7) Avoid recidivism: Client Success Stories will inspire and motivate other inmates.

Pu'uhonua participants will be asked to fill out the program's "Going Home Plan for Success Questionnaire," both pre- and post-release. This survey, modeled on a Social Determinants of Health Assessment Tool, a research tool of the National Association of Community Health Centers (NACHC) and Association of Asian Pacific Community Health Organizations (AAPCHO), includes assessments of social, economic and emotional factors of health and wellbeing. Pu'uhonua staff simplified and re-named the Survey to make it more "user-friendly" for our target population, and ensure it relates as closely as possible to their lives and experiences. Survey responses will be instrumental in shaping future program services.

Salary and fringe benefits paid to Program Director Francine Dudoit-Tagupa are not reimbursable by third-party payers. All of Waikiki Health's Native Hawaiian Healing Program and Pu'uhonua Program services are provided at no cost to clients or patients.

Sources of Pu'uhonua Prison Program funds: Waikiki Health received a grant of \$25,000 from the Chamber of Commerce Hawaii Public Health Fund (which has been fully expended) toward salary support for the Director of the Pu'uhonua Program. Waikiki Health also was awarded a two-year grant totaling \$760,000 from HMSA (October 1, 2017 through September 30, 2019) to support the expansion of Pu'uhonua's reach and services.

Except for Waikiki Health's request for FY 2020 State Grant in Aid funding, no other sources of funding have been approached to support our Pu'uhonua Prison Program for FY 2020.

Waikiki Health's Pu'uhonua Prison Program will be fully sustained through September 30, 2019 by our HMSA grant. Going forward, funds will be requested as needed to continue assisting Oahu offenders both pre- and post-release. As Pu'uhonua provides such important and urgently needed services to the target population and wider community, Waikiki Health plans to continue offering Pu'uhonua's services on an ongoing basis. Grant support will help Waikiki Health provide expanded services to more people in need.

Pu`uhonua Prison Program Staff

Francine Dudoit-Tagupa, Waikiki Health's Director of Native Hawaiian Healing and Pu'uhonua Program Director, **is widely recognized within the Native Hawaiian community,** and has achieved more than 15 years of education and over 25 years of practice in Native Hawaiian Healing modalities of *Lomilomi, Ho'oponopono, La'au Lapa'au and La'au Kahea.*

Ms. Dudoit-Tagupa has served as Waikiki Health's Director of Native Hawaiian Healing since 1998, and is a member of the agency's Leadership Team. Ms. Dudoit-Tagupa has been a Registered Nurse and Native Hawaiian Practitioner since 1978. She currently is a Cultural Advisor for the Board of the Chaminade School of Nursing.

Most pertinent to our request, Ms. Dudoit-Tagupa serves as a:

- Honolulu Federal Detention Center Community Board member
- T. J. Mahoney Community Board member
- Member of Na Limahana o Lonopuha Native Hawaiian Health Consortium

Ms. Dudoit-Tagupa, largely due to the disproportionate number of Native Hawaiians and Pacific Islanders historically incarcerated in Hawaii prisons and correctional facilities, conceived, developed and implemented the Pu'uhonua Prison Program with the complete support of Waikiki Health's Board of Directors, Officers, and all other Leadership Team members.

The pilot program, named the "**Pu`uhonua Health Education Model**," was implemented by Ms. Dudoit-Tagupa, and achieved the following successful results: (July through December 2016): **830** inmates received health education interventions; and **467** released inmates, all Native Hawaiians and Pacific Islanders, were provided a medical home at Waikiki Health.

Ms. Dudoit-Tagupa is assisted by a 1.0 FTE **Program Assistant** and a **1.0** FTE **Eligibility Specialist**, and aims to increase her staff by adding an additional 1.0 FTE Eligibility Specialist.

In addition to the Pu`uhonua program team, **medical/behavioral health outreach staff** pay monthly visits to furlough facilities to provide their services to furloughed individuals on-site. These visits enable furloughed inmates to obtain TB tests and physical exams required for Waikiki Health's Ohua Clinic in Waikiki and Makahiki Medical & Dental Clinic in McCully-Moiliili have each received recognition from the National Committee for Quality Assurance (NCQA) as a **Patient-Centered Medical Home - Level 3 (the highest level),** signifying these clinics offer a high standard of service to patients and clients.

Waikiki Health's special understanding of the Native Hawaiian and Pacific Islander communities helps gain acceptance among the target population, leading to improved health and well-being. (Waikiki Health's Chief Medical Officer, Dr. Ellliot Kalauawa, along with Francine Dudoit-Tagupa, are Native Hawaiian.) The health center's Native Hawaiian Healing services are fully integrated into Waikiki Health's system of primary medical care, and serves as a welcoming and culturally-competent path of entry for individuals who are unfamiliar or uncomfortable with western medical practices.

Waikiki Health's pilot Pu`uhonua initiative, was developed and implemented in 2016 without any funding from outside resources, as Waikiki Health is deeply committed to assisting men and women released from incarceration to help them turn their lives around and get a fresh start. Grant support from two funders enabled Waikiki Health to expand this important program and provide enhanced services to more individuals. In June 2017, Waikiki Health received a \$25,000 grant from the Chamber of Commerce Hawaii Public Health fund, which has been fully expended; and HMSA awarded a two-year grant totaling \$760,000, which will be fully expended when the grant term ends on September 30, 2019.

If awarded FY 2020 State Grant in Aid funding in support of its **Pu`uhonua Prison Program**, Waikiki Health will expand and enhance this important and urgently needed program, which addresses the **cultural**, **health and socioeconomic needs of offenders as they prepare to successfully re-enter the community**.



III. Service Summary and Outcomes

1. Describe the scope of work, tasks and responsibilities

The scope of work consists of the supply, installation and commissioning of energy-efficient products to identified locations at Waikiki Health's Makahiki Clinic. The work will include the vendor's removal and replacement of existing fixtures and systems, removal and disposal of excess material, minimization of the construction workspace and installation area to allow regular patient services to continue during performance of these upgrades.

A/C System Replacement: Makahiki Clinic's current Air Conditioning System operates with two 20-ton units on the facility's roof. New A/C units will be more efficient – necessary for cooling vaccines and pharmacy medicines and other products requiring refrigeration. And, cost-effective: Makahiki Clinic's average \$6,000/month electricity bill will be reduced by an estimated 30% – a savings of approximately \$1,800/month.

On Makahiki Clinic's second floor, one of the compressors is running at 50% capacity, and both units need to be replaced. Thermostats in all clinic rooms are no longer functioning correctly and need to be replaced. The current system produces cold areas and hot spots in various areas of the clinic; Makahiki Clinic is in need of a regulated A/C system providing uniform temperature throughout the clinic.

After the year 2020, the refrigerant Freeon, utilized in our current A/C system, will no longer be produced, and we anticipate that limited remaining supplies will become prohibitively costly and then no longer available. We propose to replace our A/C system with energy-efficient, environmentally-sound technology.

Front Door Re-design: Waikiki Health proposes to install a power-assisted entry system at Makahiki Clinic's front entrance that will allow both doors to open outward, providing access for wheelchair-users, people on crutches, and others with mobility challenges who will be able to enter the facility without waiting for assistance from clinic staff.
