No. 36 entitled:

"SENATE RESOLUTION ENCOURAGING THE DEPARTMENT OF EDUCATION TO  
IMPLEMENT OCEAN SAFETY AND STEWARDSHIP EDUCATION FOR ALL  
FOURTH GRADE PUBLIC SCHOOL STUDENTS,"

begs leave to report as follows:

The purpose and intent of this measure is to encourage the  
Department of Education to implement ocean safety and stewardship  
education for all fourth grade public school students.


Your Committee did not receive any testimony on this measure.

Your Committee finds that as an island state, ocean and water  
safety awareness at a young age is key to drowning prevention. In  
the past, the Department of Education provided water safety  
education to all public school students. Therefore, ocean safety  
and stewardship education should be reintroduced to public school  
students to increase awareness and prevent ocean drownings.

As affirmed by the record of votes of the members of your  
Committee on Education that is attached to this report, your  
Committee concurs with the intent and purpose of S.R. No. 36 and  
recommends that it be referred to your Committee on Ways and  
Means.
