## II. Background and Summary

Na Hui Ikaika is a nonprofit agency providing mentoring programs for middle and high school young females in Hawaii on the leeward side of the Big Island. The program will form partnerships with local school districts, area outrigger clubs, and other youth clubs. Na Hui Ikaika's goal is to foster a commitment to young women that will promote positive self-image, strong interpersonal skills, and reassert a sense of hope in the future. Only through personal relationships, individual empowerment, and positive self-image can a sense of responsibility be reestablished that will give youth the commitment to follow through on path to adulthood with a sense of pride and accomplishment. Na Hui Ikaika's mission is to facilitate this through the sport of outrigger canoe paddling. Na Hui Ikaika's young women team members (no associated fee to participate) will be using the sport of outrigger canoe paddling to be the best version of themselves. This agency will be mentoring young ladies through the sport and use the team atmosphere to improve upon oneself while learning the cultural aspect of the sport and a sense of responsibility to a team. The young ladies of this team will be participating in local, state, and national outrigger canoe races.

Through repeated failures, development of destructive habits, and vulnerable home environments, at-risk young people often struggle to see a positive future that awaits them if they are successful in putting their lives on the right path. To accomplish this goal, young people must be in a caring, supportive, positive environment that promotes their best self and reinforces personal respect.

Na Hui Ikaika is a program that is in direct response to the growing number of young women that are either falling through the cracks at school or home, in need of a positive mentor/role-model, and desire to better themselves as ladies and athletes. The focus is slightly different for everyone, but the overall goal remains the same; empower the young women to make positive changes in their lives, become the best version of themselves both mentally and physically through the Hawaiian sport of outrigger canoe paddling.

Na Hui Ikaika will focus primarily on middle and high school girls. This age group is when young ladies need focus and strong mentoring in order to develop a strong sense of self. This time in their lives paves the path on the direction in which their lives will go. Na Hui Ikaika mentoring programs will pair a young woman with a female athlete/mentor for 12 months. During that time the two will participate in weekly planned activities to strengthen the relationship between the two and improve the young person's confidence and hopefulness, as well as improving their physical fitness and outrigger cance paddling skills. Na Hui Ikaika young lady team members will also participate in weekly meetings as a team to blend and learn the importance of working as one. Mentors will receive continuous training throughout the year and will participate in monthly meeting to report the young person's progress. These meetings will be held at Kamakahonu Beach, Anaehoomalu Beach, Honokohau Harbor, and various public locations/beaches which are free to public usage. These weekly team meetings will be between 1.5-2.5 hours and the revenues necessary to operate the weekly meetings will be a start-up cost from purchasing the canoes. Otherwise, weekly meetings will not have an associated cost.

Over time, Na Hui Ikaika will create a cultural learning environment that will be an invaluable resource to young ladies, aspiring mentors and the community at large.

#### Objectives

Na Hui Ikaika is being established to provide physical and mental mentoring for at local Hawaiian middle and high school girls in the greater Kailua Kona area through outrigger canoe paddling. The program will create partnerships with the local schools, after school programs, and canoe club. Na Hui Ikaika matches a caring, experienced, strong, and knowledgeable woman with referred young ladies.

#### Mission

The mission of Na Hui Ikaika is the pursuit of the following principles:

**Commitment**: Na Hui Ikaika wants to inspire pro-social friendships, strong interpersonal skills, bolster their physical capabilities, and instill a sense of hope in the future.

**Responsibility**: The focus of Na Hui Ikaika is to empower young ladies in establishing goals both physically & mentally, show the importance of following through on commitments, and to teach the strength in being a part of a team.

**Possibility**: Na Hui Ikaika wants to expand the perspective of young women to make them aware of life's possibilities and to see the potential they have in life.

**Support**: An individual is dramatically influenced by their support system. Na Hui Ikaika wants to surround young women in a caring, strong, empowering learning environment that will give them the skills to be the best version of themselves.

This mission will be implemented through regular weekly meetings with individual mentors, as well as Na Hui Ikaika's entire team. Na Hui Ikaika will provide weekly trainings, technique workshops, guest speakers, cultural seminars, and community outreach. During school breaks, the Na Hui Ikaika young ladies will have the opportunities to participate in week long camps that will happen at local beach in which they will have guest speakers, cultural parishioners, and experienced paddlers bolster their knowledge and strength through outrigger canoe paddling.

#### Keys to Success

\*Establish a strong network of support with the school systems, after school programs, and local canoe clubs.

\*Launch a series of fundraising activities that will successfully fund the expanding program.

\*Establish an effective training program for mentors that will increase their ability to be successful communicators.

\*Establish an effective monitoring system to protect both the youth and the mentor.

\*Young ladies are matched with a caring, independent, strong female adult volunteer who is trained to focus on positive reinforcement, trust-building, and the achievement of goals, by engaging young ladies in one-on-one outing and group meetings in the community. Mentors and youth agree to meet for between 8-10 hours per month for a full year.

\*Ongoing training will continue with mentors on individual case management throughout the year. In addition, Na Hui Ikaika will have bi-monthly mentor support meetings. Market Analysis Summary

Na Hui Ikaika is a program that is in direct response to the growing number of young women that are either falling through the cracks at school and at home. Our program offers young women the opportunity to make a dramatic change in their lives and to be the best version of themselves both physically and mentally. The program is positioned

to be most assessable to young people who lack strong mentors in their lives and have slipped through the cracks at school or in other programs.

The goal of the program is to identify young ladies who are going have a turbulent transition to adulthood and offer positive support system to avoid the pitfalls that can derail their lives. All of this will be done as an outrigger canoe paddling team with strong female mentors facilitating practices and individual growth meetings.

#### **Market Segmentation**

Na Hui Ikaika has several market focuses that are key to the program's success. Youth who are overcoming stressors in their lives, such as poverty, discrimination, abusive situations, addictions, unstable homes, and academic life. Mentoring programs foster positive changes through goal setting, self-discipline, skill development, sports, physical fitness, and friendship.

#### **Target Market Segment Strategy**

The target market for Na Hui Ikaika are young ladies ages 12 to 18 that need strong female mentors, a team environment, physical challenges, and community focus to empower them to be the best version of themselves. Na Hui Ikaika has created a mentoring program that pairs the young women with a female mentor who will assist him or her in developing the habits and perspective that will lead to success and hopefulness in the future while learning Hawaiian culture and becoming a strong outrigger canoe paddler.

## III. Service Summary and Outcomes

As this is a brand-new service to the community and non-profit organization the scope of work to launch Na Hui Ikaika is intensive. For this organization to be successful, necessary accoutrements need to purchased, including but not limited to: at least two 6-man outrigger canoes, trailers, four two-man canoes, four one-man canoes, and various paddles for the young women.

Once the necessary equipment is purchased for the program to be successful, a recruitment and application process will start for the young ladies to be involved in the program, as well as the adult female mentors. Funding from this grant will allow training to our selected mentors to best aid and support the young ladies in the program.

Once the two teams have been established, a practice, mentor, and race schedule will be established. The funding from this grant will also help with registration fees for outrigger canoe races and travel & lodging for races not held on the Big Island of Hawaii.

The President (Kristin Joy Old) will monitor the mentors, as well as, the mentees to make sure they are meeting weekly and will be attending all practices together, as she

will be coaching the young lady's program. The president will also be in contact with the parents and the lead chaperone to local, inner island, and off-island races. The funding from this grant will also purchase insurance for Na Hui Ikaika, as an organization.

Na Hui Ikaika will be an on-going organization but will hope to grow each year. The funding for this grant will help 12 young ladies be the successful young adults through outrigger canoe paddling with the help of 12 female adult mentors. The goal is to purchase the accoutrements this year to guarantee 12 young ladies can join the organization complete the distance season and grow as individual. After this year, each young lady and adult mentor will need to reapply to be a part of Na Hui Ikaika. Our goal is to have as many young ladies as we possibly can.

Na Hui Ikaika's President and Board of Directors will ensure that the funding will go directly to the necessary equipment and expenses for the organization to be successful. Our treasurer will directly monitor and report discrepancies to the Board and it will be remedied immediately. No board members are compensated. All the funding will go directly to the necessary equipment to make the program a success. Attendance and frequency to practices, feedback from the mentees & mentors, and improvements at races will be addressed in a positive manner.
