# 1. A brief description of the applicant's background;

Pali Momi Foundation is the philanthropic arm of Pali Momi Medical Center, which provides specialty healthcare, emergency services, public health education and outreach, training, and research. Located in Aiea, Pali Momi Medical Center brings to this community life-saving

specialty care including a stroke center, a Level III Trauma Center, a dedicated Women's Center, and an interventional cardiac catheterization unit. Pali Momi was founded in 1989 and is part of the state's largest health care provider, Hawai'i Pacific Health (HPH).

The Cancer Center at Pali Momi Medical Center is the first and only comprehensive cancer center serving Central and West Oʻahu. Initially opened in 2017, this Center offers specially trained oncologists and coordinated care in a convenient location. Through a partnership with Cancer Center of Hawaiʻi, the Center brings medical oncology, radiation, infusion services, a dedicated pharmacy, and multi-disciplinary team services under one roof. This allows for patients to seamlessly commute between specialists and to access coordinate care throughout diagnosis, treatment, and recovery.

The mission of Pali Momi Foundation is to create a healthier Hawai'i.

### 2. The goals and objectives related to the request;

Pali Momi Foundation requests funding for Phase Three of the James T. Kakuda Cancer Center. Dr. James T. Kakuda was a valued leader of the Hawai'i Pacific Health family. In his tenure as Chief Medical Officer and Surgical Oncologist at Pali Momi, he was a dedicated and inspirational leader. He was instrumental in developing this 24,000 square foot space dedicated to elevating cancer care in Hawai'i.

Pali Momi Foundation seeks to further Dr. Kakuda's vision to expand this Center and to provide the best possible care, close to home, for residents of Central and West O'ahu.

Phase Three of the Cancer Center will meet three objectives:

- a) <u>Create a new multi-disciplinary clinic</u>, adding 3,330 square feet of space dedicated to cancer care and research.
- b) Expand research capacity to provide more treatment options for patients.
- c) <u>Provide designated space for holistic care</u>, including prosthetics and wig fittings, nutrition instruction, acupuncture, and massage therapy.

#### 3. The public purpose and need to be served;

This project is needed to meet the growing threat of cancer, as this disease is the second leading cause of death in Hawai'i. The Cancer Statistics Center estimates there will be 7,120 new cases diagnosed and more than 2,560 cancer deaths this year. More than \$678 million is spent every year on cancer care in the state (https://health.hawaii.gov/cancer/).

Since the Center opened in 2017, Pali Momi has met significantly higher volume than anticipated, experiencing 20% - 30% increases in service each year. The most prevalent types of cancer treated at Pali Momi are breast, prostate, lung, and colon cancers. These are the most commonly diagnosed cancers in men or women. In 2018, more than 20 different types of cancer were treated at the Center. On average, three or more physicians support each patient in a cohesive team approach.

The Cancer Center is an asset benefiting the greater community and economy. Health care organizations must keep pace with advanced technology and training methodologies in order to provide excellent care and be competitive in attracting medical professionals. As all medical centers grapple with the national shortage of healthcare clinicians, Pali Momi is especially challenged due to its location outside of the urban core of Honolulu. The proposed project is part of an institutional commitment to excellence for this community.

### 4. Describe the target population to be served; and

This project will improve the patient experience and quality of care for adults who come to Pali Momi Medical Center for cancer care. There were over 23,000 procedures performed in fiscal year 2019, which was a 20% increase over the previous year. By increasing access to care, the Center can better serve Native Hawaiian and Pacific Islander ethnic groups, which have higher rates of mortality due to cancer, compared to the general population.

Pali Momi admits over 6,000 patients, has over 50,000 emergency visits, and handles over 300 traumas per year. There are more than 50,000 procedures performed at the Women's Center annually. Approximately 63% of Pali Momi patients are over the age of 65 and about 14% of Pali Momi patients are uninsured or underinsured.

### 5. Describe the geographic coverage.

Pali Momi Medical Center is located at 98-1079 Moanalua Road, Aiea. This is the only Cancer Center serving the Central and West O'ahu areas, providing life-saving treatment and ongoing support to residents in the community.

The project will be managed by David Yamaguchi, HPH Project Manager. He will oversee the design, permitting, construction, and inspection processes for this project. Mr. Yamaguchi will monitor and evaluate the progress of the project, while providing progress reports and necessary feedback to the Capital Allocations Committee and Finance Committee. These committees will review materials estimates, approve the project budget, review construction proposals and secure a vendor, and inspect the project upon completion.

Mr. Yamaguchi will work directly with the Director of Finance and the Finance department on Project Budget approvals and spending. Quality and oversight will be facilitated through weekly coordination meetings with the staff, users, architect, and contractor called meetings.

Founded in 1989, Pali Momi Medical Center is part of Hawai'i Pacific Health (HPH), the largest health care provider in the state. Pali Momi is bringing a higher level of care to this community by improving facilities and establishing specialized care centers.

Upon opening the Cancer Center in 2017, the clinical space was operating at capacity immediately. To meet the growing demand for cancer treatment, Pali Momi expanded the Infusion Department with an additional five treatment rooms and two conference rooms with built-in video conferencing capability. The facility includes multimedia conferencing capability,

which enables physicians to discuss complex cases together in one space and work with our partners at the Seattle Cancer Care Alliance. Recent advancements include the ability to perform low-dose CT lung cancer screenings.

Concurrently with the construction of the physical space, Pali Momi is building capacity with expanded partnerships, professional development, and research opportunities. The Center strives for seamless multi-disciplinary care by encouraging coordination and communication. Patient navigators coordinate care and guide patients through their cancer journeys. Last year, 478 cancer patients received patient navigation services.

The James T. Kakuda Cancer Center is a beautiful state of the art facility. The center aesthetics and design evoke a sense of calm to alleviate the anxiety patients may experience when they are navigating cancer diagnosis and treatment. This is a healing environment with soft lighting, calming colors, and carefully curated artwork and design elements.

The Center facilities include radiation services, a medical oncology clinic, an infusion suite, multi-media conference rooms, spacious common areas, physician offices, multiple exam rooms, and lab and research space. There is ample parking, a free shuttle service, and convenient access to the adjacent Pali Momi Medical Center.

His background as a Construction Manager, Owner's Representative, and General Contractor gives him an excellent overall perspective of project management and delivery.

In his current position, Mr. Yamaguchi has managed over 70 projects representing over \$97M and currently manages \$26M in projects between Pali Momi, Wilcox Medical Center and Kaua'i Medical Clinic. Mr. Yamaguchi reports directly to Warren Chaiko, who has been with Hawai'i Pacific Health for fifteen years. Mr. Chaiko is a Senior Vice President with system-wide responsibility for the company's design, construction, leasing, real estate and facility master planning activities.

Pali Momi Foundation has one full-time and five shared employees, along with ten volunteer foundation board members. Pali Momi Medical Center has 1,074 staff members, 522 physicians, and 132 active volunteers.

Thus, Pali Momi will be competitive in attracting high-level physicians and nurses and meeting the needs of this community.
