A BILL FOR AN ACT

RELATING TO CHRONICALLY HOMELESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In 2015, the United States Department of
2	Housing and Urban Development established a definition of
3	"chronically homeless" for use in its homeless assistance
4	programs. The purpose of this Act is to amend Hawaii's
5	definition of "chronically homeless individual" to better align
6	with the federal definition and reduce confusion among service
7	providers, communities, and private partners.
8	SECTION 2. Section 346-378, Hawaii Revised Statutes, is
9	amended by amending subsection (e) to read as follows:
10	"(e) As used in this section, "chronically homeless
11	individual" means [a homeless individual who has an addiction or
12	a mental illness, or both.]:
13	(1) A homeless individual having a mental illness,
14	addiction, or physical disability who:
15	(A) Lives in a place not meant for human habitation,
16	a safe haven, or an emergency shelter; and

1		(B)	Has been homeless and living as described in
2			subparagraph (A) continuously for at least twelve
3			months or on at least four separate occasions in
4			the last three years; provided that the combined
5			occasions equal at least twelve months and each
6			break in homelessness separating the occasions
7			included at least seven consecutive nights of not
8			living in places as described in subparagraph
9			(A); provided further that stays in institutional
10			care facilities for fewer than ninety days shall
11			not constitute a break in homelessness, but shall
12			be included in the twelve-month total if the
13			individual was living in a place not meant for
14			human habitation, a safe haven, or an emergency
15			shelter immediately before entering the
16			institutional care facility;
17	(2)	An ir	ndividual who has been residing in an
18		inst	itutional care facility, including a jail,
19		subst	tance abuse or mental health treatment facility,
20		hosp	ital, or other similar facility, for fewer than

1	<u>:</u>	ninety days and met all of the criteria in paragraph
2		(1) before entering that facility; or
3	(3)	A family with an adult head of household, or a minor
4		head of household if there is no adult in the family,
5		who meets all of the criteria in paragraph (1) or (2),
6		including a family whose composition has fluctuated
7		while the head of household has been homeless."
8	SECTI	ON 3. This Act does not affect rights and duties that
9	matured, p	enalties that were incurred, and proceedings that were
10	begun befo	re its effective date.
11	SECTI	ON 4. Statutory material to be repealed is bracketed
12	and strick	en. New statutory material is underscored.
13	SECTI	ON 5. This Act shall take effect upon its approval.
