A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State has one of
- 2 the highest rates of homelessness per capita in the nation.
- 3 Additionally, the legislature finds that The Queen's Medical
- 4 Center provides the majority of medical care to the State's
- 5 homeless population. According to the Laulima Data Alliance,
- 6 from January 2016 to September 2018, The Queen's Medical Center
- 7 experienced approximately sixty per cent of all hospital visits
- 8 by homeless persons on Oahu and forty-three per cent of all
- 9 hospital visits by homeless persons in the State.
- 10 Recognizing the high needs of the State's most medically
- 11 fragile homeless populations, the legislature established the
- 12 emergency department homelessness assessment pilot program and
- 13 the medical respite pilot program in Part II of Act 209, Session
- 14 Laws of Hawaii 2018. Through contracts with the department of
- 15 human services, The Queen's Medical Center was able to provide
- 16 medical respite services and intensive care navigation services

3	Through the emergency department homelessness assessment
4	pilot program, the Queen's Care Coalition was able to identify
5	homeless patients with high utilization of emergency department
6	services and deliver short-term, post-discharge navigation
7	services to special populations to reduce reliance on acute care
8	by connecting patients to community services. The Queen's Care
9	Coalition provided one hundred thirty-one homeless adults with
10	navigation services during the contract period of September 1,
11	2018, to June 30, 2019. Of the homeless adults served:
12	(1) Ninety-four per cent were connected with community
13	resources;
14	(2) Sixty-five per cent were document-ready for housing;

16	(3) Ninety-two per cent of the individuals that were

- 1 nine per cent, the number of hospitalized days by seventeen
- 2 per cent, and the amount of ambulance utilization by fifty-three
- 3 per cent.
- 4 The legislature further finds that the work of the Queen's
- 5 Care Coalition resulted in significant cost savings to three
- 6 major Med-QUEST managed care plans. Analysis on total cost of
- 7 care pre- and post-Queen's Care Coalition demonstrates an
- 8 average of thirty-nine per cent reduction in total cost of care.
- 9 The National Health Care for the Homeless Council
- 10 recognizes medical respite as a needed service and response to
- 11 the circumstances faced by people experiencing homelessness.
- 12 Homeless individuals suffer profound disparities in health and
- 13 mortality compared to the general population. After an acute
- 14 care stay, recovery is extremely difficult on the streets and
- 15 shelters generally are not equipped to support people who are
- 16 sick or injured.
- 17 Thus, medical respite care for individuals experiencing
- 18 homelessness is a critical part of the continuum of care for
- 19 this population. Through a partnership with the Institute for
- 20 Human Services, The Queen's Medical Center is able to provide
- 21 medical respite to homeless patients who have been discharged

- 1 and may need additional time to heal in a more appropriate level
- 2 of care setting.
- 3 The legislature also finds that the emergency department
- 4 homelessness assessment pilot program merits continuation
- 5 because it has demonstrated positive results in delivering care
- 6 coordination services by a multidisciplinary team, thereby
- 7 mitigating the number of unnecessary emergency department visits
- 8 by patients experiencing homelessness and patients at risk of
- 9 experiencing homelessness. Additionally, the legislature finds
- 10 that the medical respite pilot program merits consideration
- 11 because it has demonstrated positive results in delivering
- 12 medical respite services for eligible individuals experiencing
- 13 homelessness by providing certain services, including meals;
- 14 case management; and medical, nursing, and psychiatric care.
- 15 Further, the legislature finds that the department of human
- 16 services supports the continuation of both programs and is in
- 17 the process of transitioning the programs from the department's
- 18 homeless program office to the department's Med-QUEST division.
- 19 Finally, the legislature intends that no lapse in resources
- 20 occur for the emergency department homelessness assessment pilot

- 3 The purpose of this Act is to:
- 4 (1) Extend the duration of the emergency department
- 5 homelessness assessment pilot program and the medical
