STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 1523

Honorable Members Thirtieth Legislature State of Hawai'i

Pursuant to Section 16 of Article III of the Constitution of the State of Hawai'i, I am returning herewith, without my approval, House Bill No. 1523, entitled "A Bill for an Act Relating to the Department of Education Budget."

The purpose of this bill is to specify that the costs of devices for Department of Education schools having identified needs and student populations of fifty percent or greater who qualify to receive free or reduced lunch for the period from July 1, 2020 to December 30, 2020, shall be covered using Coronavirus Aid, Relief, and Economic Security Act funds.

This bill is objectionable because it is not necessary. The Department of Education has already received funds to accomplish this purpose through the Governor's discretionary funding without limitation on the schools that are eligible.

For the foregoing reasons, I am returning House Bill No. 1523 without my approval.

### A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION BUDGET.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to facilitate the
- 2 purchase of devices for certain department of education schools,
- 3 without affecting the department's existing general fund
- 4 allotment, by specifying that the costs of these devices shall
- 5 be covered using federal moneys received by the State through
- 6 the Coronavirus Aid, Relief, and Economic Security Act (CARES
- 7 Act), Public Law 116-136, which was enacted on March 27, 2020,
- 8 to address the extensive economic impact of the coronavirus
- 9 disease 2019 (COVID-19) pandemic.
- 10 SECTION 2. Of the amount appropriated by section 37 of
- 11 Senate Bill No. 126, S.D. 1, H.D. 1, C.D. 1, to the office of
- 12 the governor to be used for eligible programs pursuant to Public
- 13 Law 116-136 and associated guidance issued by appropriate
- 14 federal agencies, the sum of \$6,400,000 or so much thereof as
- 15 may be necessary for fiscal year 2020-2021 shall be used for the
- 16 purposes of covering the costs of devices for schools having
- 17 identified needs and student populations of fifty per cent or

- SECTION 3. This Act shall take effect upon its approval. 3
