A BILL FOR AN ACT

RELATING TO ESTABLISHING THE EXECUTIVE OFFICE ON AGING ADMINISTRATIVE CLAIMING SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Federal financial participation under Medicaid 2 is a percentage of state expenditures that can be reimbursed by 3 the federal government to pay for administrative and program 4 costs of state agencies or other entities that provide long-term 5 services and supports to Medicaid clients. In Hawaii, the 6 executive office on aging and the aging and disability resource 7 centers are eligible for federal financial participation because 8 they spend money on administrative functions to provide long-9 term services and supports to Medicaid clients. If the 10 executive office on aging and the aging and disability resource 11 centers were to receive their share of federal financial 12 participation for administrative costs, they would be able to expand their programs and services and serve more individuals. 13 14 Furthermore, if federal financial participation could be 15 directly deposited into a special fund established in the 16 executive office on aging, funds could be easily distributed to

the aging and disability resource centers to support the work
they were established to perform pursuant to section 349-32,
Hawaii Revised Statutes.

4 The State is currently not receiving federal funds it is 5 eligible to receive. It is estimated that the annual federal 6 financial participation claims for the executive office on aging 7 and the four aging and disability resource centers would equal \$1,283,000 in state fiscal year 2018-2019, \$1,443,000 in state 8 9 fiscal year 2019-2020, \$1,686,000 in state fiscal year 2020-10 2021, \$1,887,000 in state fiscal year 2021-2022, and \$2,036,000 11 in state fiscal year 2022-2023. According to the Administration 12 for Community Living of the United States Department of Health 13 and Human Services, most states claim between \$500,000 to 14 \$2,000,000 per year.

15 The purpose of this Act is to establish the executive 16 office on aging administrative claiming special fund to enhance 17 the drawdown of anticipated federal funds and provide additional 18 moneys to support services for kupuna and individuals with 19 disabilities who need long term services and supports.

20 SECTION 2. Chapter 349, Hawaii Revised Statutes, is 21 amended by adding a new section to be appropriately designated 22 and to read as follows:

1	"§349- Executive office on aging administrative claiming
2	special fund. (a) There is established in the state treasury
3	the executive office on aging administrative claiming special
4	fund. The fund shall be administered and expended by the
5	department of health. The fund shall consist of:
6	(1) All revenues from medicaid administrative claiming
7	designated for the department of health that are
8	allowable for operating the aging and disabilities
9	resource centers;
10	(2) Appropriations made by the legislature to the fund;
11	and
12	(3) Grants and gifts made to the fund.
13	(b) Moneys in the executive office on aging administrative
14	claiming special fund shall be used by the department of health
15	to implement section 349-32 for services for kupuna and
16	individuals with disabilities who need long-term services and
17	supports."
18	SECTION 3. Section 36-27, Hawaii Revised Statutes, is
19	amended by amending subsection (a) to read as follows:

22	time, the director of finance, for the purpose of defraying the
23	prorated estimate of central service expenses of government in

JUSTIFICATION SHEET

DEPARTMENT: HEALTH

TITLE: A BILL FOR AN ACT RELATING TO ESTABLISHING THE EXECUTIVE OFFICE ON AGING ADMINISTRATIVE CLAIMING SPECIAL FUND.

- PURPOSE: To capture new revenue based on the percentage of state expenditures to be reimbursed by the federal government for the administrative and program costs of state agencies or other entities that provide long-term services and supports to Medicaid clients, and deposit those funds into a newly created special fund to support services for kupuna and individuals with disabilities who need long-term services and supports.
- MEANS: Add a new section to chapter 349, Hawaii Revised Statutes (HRS), and amend sections 36-27 and 36-30, HRS.
- JUSTIFICATION: The state is currently not receiving federal financial participation funds with which the federal government reimburses state agencies or other entities for providing long-term services and supports to Medicaid clients. The executive office on aging is in the process of submitting a claim for its share of federal financial participation funds that are a percentage of state expenditures reimbursed by the federal government for administrative and program costs of the Medicaid program. Findings from a 2016 random moment time study estimated that the state may be reimbursed between \$1,400,000 and \$2,000,000 in federal financial participation claims for the executive office on aging and the aging and disability resource centers. A special fund is needed to deposit federal reimbursement funds so the executive office on aging can distribute

the money to the aging and disability resource centers for services to kupuna and individuals with disabilities who need longterm services and supports. As the funds to be deposited to the special fund are Medicaid reimbursement funds, it would be appropriate to exempt the fund from the surcharges of sections 36-27 and 36-30, HRS.

<u>Impact on the public:</u> Vulnerable populations may benefit from additional program moneys for direct services and supports.

Impact on the department and other agencies: This will provide the Department of Health additional moneys for services for kupuna and individuals with disabilities. If approved, the Department of Budget and Finance is required to establish the special fund.

- GENERAL FUND: None.
- OTHER FUNDS: Additional federal funds reimbursement may range from \$500,000 to \$2,000,000 annually, based on the experiences of other states.
- PPBS PROGRAM DESIGNATION: HTH 970.
- OTHER AFFECTED AGENCIES: Department of Budget and Finance; County Aging and Disability Resource Centers.
- EFFECTIVE DATE: Upon approval.
