A BILL FOR AN ACT

RELATING TO THE INTERSTATE WILDLIFE VIOLATOR COMPACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Interstate Wildlife Violator Compact is a 2 multistate agreement that promotes enforcement of hunting, 3 fishing, trapping, and other wildlife related regulations across 4 jurisdictions. For example, the Interstate Wildlife Violator 5 Compact could prevent wildlife violators who have lost their hunting, fishing, trapping, or other wildlife related privileges 6 7 in other member states from obtaining a hunting license in 8 Similarly, persons who have been punished with license Hawaii. 9 revocation in Hawaii would be unable to avoid this punishment by 10 engaging in those activities in another state. The Interstate 11 Wildlife Violator Compact also establishes a process by which 12 nonresident wildlife law violators can be treated as state 13 residents for purposes of law enforcement, thereby easing the 14 administrative burden on the enforcement agency and reducing 15 enforcement gaps that may allow the violator to fail to comply 16 with the terms of the citation. Reciprocity agreements such as

the Interstate Wildlife Violator Compact are an important part
 of any law enforcement effort.

3 The Interstate Wildlife Violator Compact is modeled after
4 the successful multistate driver license compact and nonresident
5 violator compact. Hawaii is party to both compacts.

6 Forty-eight states have passed legislation necessary to 7 join the Interstate Wildlife Violator Compact. Existing member 8 states to the Interstate Wildlife Violator Compact have reported 9 little to no added costs or administrative burdens associated 10 with participating in the compact. The information system that 11 facilitates participation is available for a nominal annual fee 12 (\$500) to member states.

13 The purpose of this Act is to authorize the department of 14 land and natural resources to enter into the Interstate Wildlife 15 Violator Compact or similar agreement for mutual assistance in 16 the enforcement of wildlife laws.

SECTION 2. Chapter 183D, Hawaii Revised Statutes, is
amended by adding to part I a new section to be appropriately
designated and to read as follows:

20 "<u>§183D-</u> Interstate wildlife violator compact. (a) The
21 department may enter into the interstate wildlife violator

2	memorandum of understanding, written agreement, or mutual aid
3	compact, with an appropriate state, federal, or foreign entity
4	for mutual assistance in the enforcement of hunting, fishing,
5	and other wildlife laws, rules, or regulations in their
6	respective jurisdictions.
7	(b) The department may adopt rules pursuant to chapter 91
8	necessary for enforcement of the agreement entered into pursuant
9	to subsection (a)."
10	SECTION 3. New statutory material is underscored.
11	SECTION 4. This Act shall take effect on July 1, 2050.
