

A BILL FOR AN ACT

RELATING TO MINIMUM WAGE.

RE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 387-2, Hawaii Revised Statutes, is 1 SECTION 1. amended by amending subsection (a) to read as follows: 2 Except as provided in section 387-9 and this section, 3 "(a) 4 every employer shall pay to each employee employed by the employer, wages at the rate of not less than: 5 6 \$6.25 per hour beginning January 1, 2003; (1) \$6.75 per hour beginning January 1, 2006; 7 (2) (3) \$7.25 per hour beginning January 1, 2007; 8 \$7.75 per hour beginning January 1, 2015; 9 (4)\$8.50 per hour beginning January 1, 2016; 10 (5) 11 (6) \$9.25 per hour beginning January 1, 2017; [and] \$10.10 per hour beginning January 1, 2018 [-]; and 12 (7) \$ per hour beginning January 1, ." 13 (8) 14 SECTION 2. Section 387-9, Hawaii Revised Statutes, is 15 amended to read as follows: Special minimum wages for learners; apprentices; 16 "§387-9 full-time students; paroled wards of Hawaii youth correctional 17

 than eighteen years of age, wages at the rate of not less than

- eighty-five per cent of the rate established in section 387-2(a) 1
- 2 for the first ninety days of that employee's employment.
- [(b)] (c) The director may by rule prescribe standards and 3
- 4 requirements to ensure that this section will not create a
- substantial probability of reducing the full-time employment 5
- 6 opportunities of persons other than those to whom the special
- minimum wage rate authorized by this section is applicable." 7
- 8 SECTION 3. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.
- 11 SECTION 4. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 5. This Act shall take effect on January 1, 2019.
