# A BILL FOR AN ACT

RELATING TO BAG LIMITS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the department of SECTION 1. 2 land and natural resources has adopted various administrative 3 rules regulating the taking, killing, or possession of spiny 4 lobster (ula), Kona crab (ranina ranina), and Samoan crab 5 (Scylla serrata). The legislature further finds that section 6 188-58.5, Hawaii Revised Statutes, also regulates the taking or 7 killing of the female sex of spiny lobster (ula), Kona crab 8 (ranina ranina), and Samoan crab (Scylla serrata). The 9 legislature recognizes that having these somewhat conflicting, 10 dual regulations often creates confusion.

11 The purpose of this Act is to remove any conflicts that may 12 exist between the Hawaii Administrative Rules and Hawaii Revised 13 Statutes regarding the taking or killing of certain crustaceans 14 by repealing the statutory prohibition on taking or killing of 15 the female sex of spiny lobsters, Kona crabs, and Samoan crabs. 16 SECTION 2. Section 188-58.5, Hawaii Revised Statutes, is 17 repealed.

15	female spiny lobsters, Kona crabs, and Samoan crabs by the
16	effective date of this Act; provided further that if the
17	department of land and natural resources adopts administrative
18	rules that regulate the taking or killing of female spiny
19	lobsters, Kona crabs, and Samoan crabs, this Act shall take
20	effect upon the effective date of those administrative rules.
