A BILL FOR AN ACT

RELATING TO TOURISM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Ţ	PART 1
2	SECTION 1. The legislature finds that tourism is the
3	largest private sector industry in the State and that Hawaii is
4	known globally for stunning natural beauty, unique culture, and
5	the spirit of aloha. A successful tourism industry in Hawaii
6	depends on the health of natural and cultural resources,
7	communities, economy, and relationships with visitors.
8	The legislature further finds that the tourism industry has
9	a prominent role to play in protecting the State's natural
10	resources, perpetuating Hawaii's history, and preserving a high
11	quality of life for Hawaii's residents, by switching the focus
12	of the State's tourism industry from marketing Hawaii to helping
13	to manage Hawaii's resources. The legislature additionally
14	finds that requiring sustainable practices and professional tour
15	guide certification from persons in the tourism industry will
16	advance this goal, in addition to enhancing visitor experiences
17	and protecting Hawaii's brand.

- Beginning July 1, 2022, require applicants for new or 2 (1)renewal commercial use permits in state parks, small boat harbors, and ocean recreation management areas; instructor/operator permits; and common carrier certificates and contract carrier permits covering the transportation of passengers to hold and annually 8 maintain a sustainable tourism certificate from the 9 Hawaii Ecotourism Association, achieve and maintain 10 green business recognition by the Hawaii green 11 business program, and ensure that at least one-third 12 of staff members employed by the applicant who have direct contact with visitors are certified as 13 14 professional tour guides by the University of Hawaii;
 - (2) Require the University of Hawaii to update the certification for professional tour guides curriculum and examination, subject to approval by the aha moku advisory committee, by June 30, 2020, and every ten years thereafter; and
- (3) Require recertification and renewal of certification

Description:

Beginning July 1, 2022, requires persons who use the Na Ala Hele trail system for commercial purposes and applicants for new and renewal commercial use permits in state parks, small boat harbors, and ocean recreation management areas; instructor/operator permits; and common carrier certificates and contract carrier permits covering the transportation of passengers to hold and annually maintain a sustainable tourism certificate from the Hawaii Ecotourism Association, achieve and maintain green business recognition by the Hawaii Green Business Program, and ensure that at least one-third of staff members employed by the applicant who have direct contact with visitors are certified as professional tour guides. Requires the University of Hawaii to update the certification for professional tour guides curriculum and examination, subject to approval by the aha moku advisory committee, by June 30, 2020, and every ten years thereafter. Requires recertification and renewal of certification for professional tour guides every two years.
