A BILL FOR AN ACT

RELATING TO TEACHER SALARIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that it is becoming
- 2 increasingly difficult in the State to find and retain classroom
- 3 teachers at hard-to-staff schools. The legislature further
- 4 finds that encouraging and incentivizing classroom teachers to
- 5 teach in these schools will greatly improve the quality of
- 6 education in Hawaii.
- 7 The purpose of this Act is to require that classroom
- 8 teachers who teach at hard-to-staff schools be paid the greater
- 9 of:
- 10 (1) A salary that equals at least the national average
- 11 salary of classroom teachers with similar experience
- in a similar position, forgoing the annual
- differential of \$3,000 paid to licensed teachers,
- including public charter school teachers, employed at
- hard-to-staff locations; or
- 16 (2) The salary and benefits established in the teachers'
- salary schedule pursuant to section 302A-624.

2	amended t	to read as follows:
3	"§30	2A-624 Teachers' salary schedule. (a) The salary
4	schedule	for all teachers of the department shall be negotiated
5	pursuant	to section 89-9.
6	(b)	All teachers shall meet the following requirements:
7	(1)	A teacher shall earn at least five credits within a
8		three-year cycle to receive increment or longevity
9		step increases in the third year of the three-year
10		cycle;
11	(2)	A teacher who fails to meet the requirement set forth
12		in paragraph (1) shall not be eligible for any
13		increment or longevity step increases until the
14		teacher earns the credit requirement for the three-
15		year cycle;
16	(3)	Any credit earned in excess of any three-year credit
17		requirement may not be carried over beyond the three-
18		year cycle; and
19	(4)	Credits earned may be in the form of in-service,
20		university, or other credits approved by the

department.

- 12 providing direct instruction to students in a classroom setting
- 13 related to a specific subject or grade level. This definition
- 14 specifically excludes counselors, administration, and
- 15 specialists without a dedicated class.
- 16 "National average salary" means the appropriate and
- 17 applicable national average salary for teachers established by
- 18 the United States Department of Education."
- 19 SECTION 3. This Act does not affect rights and duties that
- 20 matured, penalties that were incurred, and proceedings that were
- 21 begun before its effective date.

- 1 SECTION 4. New statutory material is underscored.
- 2 SECTION 5. This Act shall take effect on January 1, 2050.

Report Title:

Teacher Salaries; Incentive; Hard-To-Staff Locations.

Description:

Requires that classroom teachers who accept long-term assignments at hard-to-staff schools be paid the greater of a salary that equals at least the national average salary of classroom teachers with similar experience in a similar position, or paid the salary benefits statutorily established under the teachers' salary schedule; and forgo the annual differential paid to teachers employed at hard-to-staff locations.
