

### A BILL FOR AN ACT

RELATING TO SHOOTING RANGE PROTECTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that shooting ranges in
- 2 Hawaii serve as valuable resources for target shooting and
- 3 firearm safety training. Shooting ranges and target shooting
- 4 facilities are important public recreation resources and provide
- 5 essential facilities and services, at minimal cost, for state
- 6 and local law enforcement agency personnel to better enhance
- 7 their required firearm skills training.
- 8 The continued existence and viability of shooting ranges is
- 9 currently under threat and still negatively impacted in the
- 10 State of Hawaii. Hawaii has not yet passed legislation related
- 11 to shooting ranges and their immediate surroundings and
- 12 acoustics. The legislature finds that it is time to pass
- 13 relevant legislation to encourage hunters, law enforcement
- 14 agencies, and the general public to freely exercise their
- 15 constitutional right.
- 16 The purpose of this Act is to provide protections to
- 17 shooting range operators and individuals engaged in target

- 3 SECTION 2. Chapter 134, Hawaii Revised Statutes, is
- 4 amended by adding a new section to Part I to be appropriately
- 5 designated and to read as follows:
- 6 "\$134- Shooting Range Protection (a) Notwithstanding any
- 7 other provision of law, a person who operates or uses a sport
- 8 shooting range in this state shall not be subject to civil
- 9 liability or criminal prosecution in any matter relating to
- 10 noise or noise pollution resulting from the operation or use of
- 11 a shooting range in compliance with applicable noise control
- 12 laws or ordinances established after the date of initial
- 13 construction or operation of the range.
- 14 (b) A person who operates or uses a shooting range is not
- 15 subject to an action for nuisance, and no court of the state
- 16 shall enjoin the use or operation of a range on the basis of
- 17 noise or noise pollution, if the range is in compliance with any
- 18 noise control laws or ordinances established on or prior to the
- 19 date of initial construction or operation of the range.
- 20 (c) Rules adopted by any state department or agency for
- 21 the purpose of limiting noise decibel levels that may occur in

- 1 the outdoor atmosphere do not apply to a shooting range exempted
- 2 from liability under this section.
- 3 (d) A person who acquires title to, or who owns, real
- 4 property adversely affected by the use of property with a
- 5 permanently located and improved shooting range shall not
- 6 maintain a nuisance action against an individual who owns the
- 7 range to restrain, enjoin, or impede the use of the range where
- 8 there has not been a substantial change in the nature of the use
- 9 of the range.
- (e) Any sport shooting range that is lawfully operated
- 11 pursuant to existing law at the time of enactment of an
- 12 ordinance shall be permitted continued operational use of the
- 13 shooting range despite nonconformance to new ordinance or
- 14 amendment to an existing ordinance.
- 15 (f) A person who participates in sport shooting at a
- 16 shooting range accepts the risks associated with the sport to
- 17 the extent the risks are obvious and inherent. Those risks
- 18 include, but are not limited to, injuries that may result from
- 19 noise, discharge of projectile or shot, malfunction of sport
- 20 shooting equipment not owned by the shooting range, natural
- 21 variations in terrain, surface or subsurface, weather

- 3 (g) Except as otherwise provided in this section, this
- 4 section does not prohibit local government from regulating the
- 5 location and construction of a shooting range after the
- 6 effective date of this section.
- 7 (h) As used in this section "local government" means a
- 8 county, city, or town. "Shooting range" or "range" means an area
- 9 designed and operated for the use of firearms, rifles, shotguns,
- 10 pistols, silhouettes, skeet, trap, black powder, or any other
- 11 similar sport shooting."
- 12 SECTION 4. New statutory material is underscored.
- 13 SECTION 5. This Act shall take effect on July 1, 2019.
