A BILL FOR AN ACT

RELATING TO LIQUOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that an ongoing problem
- 2 in several communities across the State is the sale of liquor by
- 3 unlicensed operators or entities that are not under the
- 4 jurisdiction of the liquor control agencies. Liquor control
- 5 agencies are restricted from executing compliance checks on
- 6 establishments without liquor licenses. The reportedly
- 7 widespread unlicensed sale of liquor on private properties
- 8 within the State, if true, undermines the mission of liquor
- 9 control agencies to control the sale of liquor.
- The legislature also finds that on November 1, 2017, the
- 11 Honolulu city council expressed the will of the people through
- 12 the unanimous adoption of Resolution 17-280, CD1, entitled
- 13 "Requesting the Hawaii State Legislature to increase the penalty
- 14 for the unlicensed manufacture or sale of liquor to a felony and
- 15 to add the crime to the class of organized criminal activities
- 16 under Hawaii Revised Statutes Chapter 842."

1 The resolution states, "because these unlicensed operators 2 and establishments are operating without regulation, they draw crowds and attract other illegal activity that poses health, 3 4 safety, and community concerns, as evidenced by the recent fatal 5 shooting at a well-known, but unlicensed, bar establishment that 6 has been in operation for a number of years . . . " 7 Under existing law, the penalty for the misdemeanor offense of unlicensed manufacture or sale of liquor is a fine of not 8 more than \$2,000, imprisonment for not more than one year, or 9 The intent of this Act is to deter future illegal liquor 10 11 sales, not occurring under the oversight of liquor control agencies, by increasing the consequences of subsequent 12 conviction and to allow greater latitude to judges in their 13 sentencing options. 14 The purpose of this Act is to increase the penalty for the 15 unlicensed sale of liquor and add the crime to the definitions 16 of "organized crime" and "racketeering activity" while also 17 establishing an affirmative defense for those operating in good 18

faith who reasonably believe that their actions were in

accordance with the law.

- 1 SECTION 2. Section 281-101, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§281-101 [Manufacture or sale without license;]
- 4 Unlicensed manufacture or sale of liquor; penalty. (a) If any
- 5 person, acting in person or by or through any agent, servant, or
- 6 employee, manufactures [or sells] any liquor, either directly or
- 7 indirectly, or upon any pretense or by any subterfuge, except as
- 8 authorized pursuant to this chapter, the person shall be fined
- 9 not more than \$2,000 or imprisoned not more than one year, or
- 10 both.
- 11 (b) If any person, acting in person or by or through any
- 12 agent, servant, or employee, sells any liquor, either directly
- 13 or indirectly, or upon any pretense or by any subterfuge, except
- 14 as authorized pursuant to this chapter, the person shall be
- 15 quilty of a class C felony.
- (c) It is an affirmative defense to prosecution under this
- 17 section that the defendant acted under good faith and a
- 18 reasonable belief that the sale of liquor was authorized
- 19 pursuant to this chapter."
- 20 SECTION 3. Section 712A-4, Hawaii Revised Statutes, is
- 21 amended to read as follows:

4	(b)	Murder, kidnapping, labor trafficking, unlicensed sale

7		into motor vehicle, burglary, money laundering,
8		trademark counterfeiting, insurance fraud, promoting a
9		dangerous, harmful, or detrimental drug, commercial
10		promotion of marijuana, methamphetamine trafficking,
11		manufacturing of a controlled substance with a child
12		present, promoting child abuse, promoting
13		prostitution, sex trafficking, solicitation of a minor
14		for prostitution, habitual solicitation of
15		prostitution, or electronic enticement of a child that
16		is chargeable as a felony offense under state law;
17	(c)	The manufacture, sale, or distribution of a controlled
18		substance in violation of chapter 329, promoting
19	•	detrimental drugs or intoxicating compounds, promoting
20		pornography, promoting pornography for minors, or
21		solicitation of prostitution near schools or public

1	parks, which is chargeable as a felony or misdemeanor	
2	offense, but not as a petty misdemeanor, under state	
3	law; and	
4	(d) The attempt, conspiracy, solicitation, coercion, or	
5	intimidation of another to commit any offense for	
6	which property is subject to forfeiture."	
7	SECTION 4. Section 842-1, Hawaii Revised Statutes, is	
8	amended as follows:	
9	1. By amending the definition of "organized crime" to	
10	read:	
11	""Organized crime" means any combination or conspiracy to	
12	engage in criminal activity as a significant source of income of	
13	livelihood, or to violate, aid, or abet the violation of	
14	criminal laws relating to prostitution, gambling, loan sharking,	
15	drug abuse, illegal drug distribution, counterfeiting,	
16	extortion, labor trafficking, unlicensed sale of liquor, or	
17	corruption of law enforcement officers or other public officers	
18	or employers."	
19	2. By amending the definition of "racketeering activity"	
20	to read:	

- 1 ""Racketeering activity" means any act or threat involving
- 2 but not limited to murder, kidnapping, gambling, criminal
- 3 property damage, robbery, bribery, extortion, labor trafficking,
- 4 unlicensed sale of liquor, theft, or prostitution, or any
- 5 dealing in narcotic or other dangerous drugs that is chargeable
- 6 as a crime under state law and punishable by imprisonment for
- 7 more than one year."
- 8 SECTION 5. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.
- 11 SECTION 6. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 7. This Act shall take effect upon its approval.
