A BILL FOR AN ACT

RELATING TO DRIVER'S LICENSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that Hawaii has the
 highest percentage of transgender-identifying individuals in the
 United States, and that overall they experience high levels of
 discrimination in every area of life. Hawaii has been at the
 forefront of policies offering protection to transgender people,
 and should continue to take proactive measures.

7 The legislature further finds that a University of Hawaii 8 report found that gender-stereotypical policies and norms 9 continue to stigmatize and exclude transgender people in the 10 state. According to the state department of health's 2018 11 sexual and gender minority health report, the stigmatized 12 minority status of transgender individuals is causing negative 13 and disproportionate health outcomes, economic opportunities, 14 and sociopolitical power.

15 The legislature additionally finds that currently, the 16 limited purpose driver's license is sex-marked. The legislature 17 finds that sex markers on identity documents enable sex-identity

1 and gender-identity discrimination and are not rationally 2 related to a legitimate policy goal. Mandatory binary 3 classification does not accommodate the wide range of natural 4 biological variations or gender expressions. Additionally, it 5 is overly burdensome for transgender individuals to obtain a new 6 sex or gender on a driver's license. The existing statute 7 provides institutional cover for administrative agents to 8 express transgender animus. 9 The purpose of this Act is to allow transgender and gender-10 nonconforming individuals to avoid invasive questioning and 11 discriminatory treatment by removing gender or sex markers from 12 limited purpose driver's licenses and limited purpose 13 provisional driver's licenses. 14 SECTION 2. Section 286-104.5, Hawaii Revised Statutes, is 15 amended to read as follows: 16 "[{] §286-104.5[}] Limited purpose driver's license, 17 limited purpose provisional driver's license, and limited 18 purpose instruction permits. (a) Notwithstanding section 19 286-104(7) to the contrary, every person who submits an 20 application for a driver's license, provisional driver's 21 license, or instruction permit that satisfies the requirements

3 (c) Every limited purpose driver's license, limited purpose provisional driver's license, and limited purpose 4 5 instruction permit issued pursuant to this section shall on its 6 face and machine readable zone bear the phrase, "Not acceptable for official federal purposes", and on its reverse bear the 7 8 phrase, "This license is issued only as a license to drive a 9 motor vehicle. It does not establish eligibility for 10 employment, voter registration, or public benefits", and be of a 11 unique design or color indication that clearly distinguishes 12 them from the State's compliant driver's licenses, provisional driver's licenses, and instruction permits. 13 If the United 14 States Department of Homeland Security determines that limited 15 purpose licenses or permits issued pursuant to this section do 16 not satisfy the requirements of title 6 Code of Federal 17 Regulations section 37.71, adopted pursuant to section 202 of 18 the REAL ID Act of 2005, Public Law 109-13, the examiner of 19 drivers, under the direction of the department, shall modify the 20 limited purpose licenses and permits issued pursuant to this

section only to the extent necessary to satisfy the requirements
 of the federal law.

3 (d) Every limited purpose driver's license and limited
4 purpose provisional driver's license shall expire in accordance
5 with section 286-106, and every limited purpose instruction
6 permit shall expire in accordance with section 286-110.

7 (e) A limited purpose driver's license or limited purpose
8 provisional driver's license may be renewed in accordance with
9 section 286-107 and reactivated in accordance with section
10 286-107.5. A limited purpose instruction permit may be renewed
11 in accordance with section 286-110.

(f) It shall be a violation of law to discriminate against a person because the person applied for, was denied, was issued, holds, or presents a limited purpose driver's license, limited purpose provisional driver's license, or limited purpose instruction permit.

17 (g) A limited purpose license or limited purpose
18 instruction permit issued pursuant to this section shall not be
19 used to consider a person's citizenship or immigration status as
20 a basis for a criminal investigation, arrest, or detention.
