#### A BILL FOR AN ACT

RELATING TO EMPLOYMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the employment 2 practices laws under sections 378-2, 378-2.3, 378-2.5, and 3 378-2.7, Hawaii Revised Statutes, relate to discriminatory practices, unequal pay due to sex discrimination, and employer 4 5 investigations into criminal conviction records and credit 6 history, respectively. These sections were enacted to prohibit 7 employment discrimination against individuals based upon 8 protected categories but were not intended to prevent employers 9 from taking employment action for reasons unrelated to the 10 categories protected by the legislature in those sections.

A Hawaii Supreme Court decision, Adams v. CDM Media USA, Inc., prohibits an employer from carrying its burden of production to support that the employer legitimately refused to hire an applicant solely by alleging that the applicant did not meet a non-mandatory core job function that was stated in the posting for the open position. This ruling unreasonably narrows the basis upon which an employer can decline to hire applicants.

1 This can result in costly litigation even when a non-2 discriminatory reason that is not based on a protected 3 classification supports the disqualification of an applicant. 4 The purpose of this Act is to state the legislature's 5 intent and to clarify that Hawaii's anti-discrimination law, as 6 set forth in part I of chapter 378, Hawaii Revised Statutes, 7 does not prohibit refusals to hire, refusals to refer, or 8 terminations of employment that are not based on any prohibited 9 discriminatory practices in section 378-2, unequal pay due to 10 sex discrimination as prohibited in section 378-2.3, criminal 11 conviction record inquiries prohibited in section 378-2.5, and 12 credit history inquiries prohibited in section 378-2.7, Hawaii 13 Revised Statutes. 14 SECTION 2. Section 378-3, Hawaii Revised Statutes, is 15 amended to read as follows: "§378-3 Exceptions. Nothing in this part shall be deemed 16 17 to: Repeal or affect any law, ordinance, or government 18 (1)19 rule having the force and effect of law; 20 Prohibit or prevent the establishment and maintenance (2) 21 of bona fide occupational qualifications reasonably

1 any person who has been convicted of any criminal offense involving dishonesty or a breach of trust, 2 3 unless it has the prior written consent of the federal agency having jurisdiction over the financial 4 5 institution to hire or retain the person; Preclude any employee from bringing a civil action for 6 (10)7 sexual harassment or sexual assault and infliction of 8 emotional distress or invasion of privacy related 9 thereto; provided that notwithstanding section 368-12, 10 the commission shall issue a right to sue on a complaint filed with the commission if it determines 11 12 that a civil action alleging similar facts has been filed in circuit court; or 13 14 (11) Require the employer to accommodate the needs of a nondisabled person associated with or related to a 15 person with a disability in any way not required by 16 title I of the Americans with Disabilities Act." 17 SECTION 3. Statutory material to be repealed is bracketed 18 and stricken. New statutory material is underscored. 19
