A BILL FOR AN ACT

RELATING TO GOVERNMENT SERVICES RELATING TO THE LAW.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I. GENERAL PROVISIONS

SECTION 1. The purpose of this Act is to establish the
operating budget for the fiscal biennium beginning July 1, 2019,
and ending June 30, 2021, for state executive branch programs
under the purview of the house of representatives standing
committee on judiciary.

7 SECTION 2. DEFINITIONS. Unless otherwise clear from the8 context, as used in this Act:

9 "Expending agency" means the executive department, 10 independent commission, bureau, office, board, or other 11 establishment of the state government (other than the legislature, office of Hawaiian affairs, and judiciary), the 12 political subdivisions of the State, or any quasi-public 13 institution supported in whole or in part by state funds, which 14 is authorized to expend specified appropriations made by this 15 16 Act.

9 SECTION 3. APPROPRIATIONS. The following sums, or so much 10 thereof as may be sufficient to accomplish the purposes and 11 programs designated herein, are hereby appropriated or 12 authorized, as the case may be, from the means of financing 13 specified to the expending agencies designated for the fiscal 14 biennium beginning July 1, 2019, and ending June 30, 2021. The 15 total expenditures and the number of positions in each fiscal year of the biennium shall not exceed the sums and the position 16 17 ceilings indicated for each fiscal year, except as provided 18 elsewhere in this Act or as provided by general law.

5	the Act and each and every other provision thereof shall not be
6	affected thereby. If any portion of a specific appropriation is
7	held to be invalid for any reason, the remaining portion shall
8	be expended to fulfill the objective of the appropriation to the
9	extent possible.
10	SECTION 5. If manifest clerical, typographical, or other
11	mechanical errors are found in this Act, the governor may
12	correct the errors.
13	SECTION 6. This Act shall take effect on July 1, 2019.
