- (3) Any relevant recommendations for legislative action or

- 3 2. By amending section 4 to read:
- 4 "SECTION 4. This Act shall take effect upon its approval,
- 5 and shall apply to applications for a lease to continue a
- 6 previously authorized disposition of water rights that are
- 7 pending before the board of land and natural resources on the
- 8 effective date of this Act or filed with the board of land and
- 9 natural resources on or after the effective date of this Act,
- 10 but prior to June 30, [2019;] 2026; provided that:
- 11 (1) This Act shall be repealed on June 30, [2019,] 2026,
- and section 171-58(c), Hawaii Revised Statutes, shall
- be reenacted in the form in which it read on the day
- 14 prior to the effective date of this Act; and
- 15 (2) Any holdovers first applied for under this Act prior
- 16 to June 30, [2019,] 2026, may be reauthorized, as provided in
- 17 section 1 of this Act, beyond June 30, [2019.] 2026."
