A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF PUBLIC SAFETY OPERATING BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to provide funding
for the operations of the department of public safety for the
fiscal biennium beginning July 1, 2019, and ending June 30,
2021.

5 SECTION 2. The following sums, or so much thereof as may be sufficient to accomplish the purposes and programs designated 6 herein, are hereby appropriated or authorized, as the case may 7 be, from the means of financing specified to the department of 8 public safety for the fiscal biennium beginning July 1, 2019, 9 and ending June 30, 2021. The total expenditures and the number 10 of positions in each fiscal year of the biennium shall not 11 12 exceed the sums and the position ceilings indicated for each 13 fiscal year, except as provided elsewhere in this Act or as 14 provided by general law.
