A BILL FOR AN ACT

RELATING TO FAMILY LEAVE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that approximately sixty-2 three thousand children under age eighteen live in homes where 3 householders are grandparents or other relatives. Approximately 4 forty-seven thousand of these children live with grandparents. 5 The legislature also finds that there is a growing number of grandparents raising grandchildren and who are primary 6 7 caretakers of their grandchildren. While Hawaii's family leave 8 law allows employees to take family leave upon the birth of the 9 employee's child, the employee's adoption of a child, or to care 10 for the employee's child, spouse, reciprocal beneficiary, 11 sibling, or a parent with a serious condition, family leave does 12 not extend to care for employees' grandchildren. 13 The purpose of this Act is to extend family leave in the

14 State to include care for grandchildren.

15 SECTION 2. Chapter 398, Hawaii Revised Statutes, is 16 amended by adding two new sections to part I to be appropriately 17 designated and to read as follows:



1	" <u>§398-A</u> Family leave requirement; grandparents. (a) An
2	employee who is a grandparent shall be entitled to a total of
3	one week of family leave during any calendar year to care for
4	the employee's grandchild with a serious health condition.
5	(b) During each calendar year, the leave may be taken
6	intermittently.
7	(c) Leave shall not be cumulative.
8	(d) If unpaid leave under this chapter conflicts with the
9	unreduced compensation requirement for exempt employees under
10	the federal Fair Labor Standards Act, an employer may require
11	the employee covered by this section to make up the leave within
12	the same pay period.
13	(e) Nothing in this chapter shall entitle an employee
14	covered by this section to more than a total of one week of
15	leave in any twelve-month period.
16	<u>§398-B</u> Unpaid leave permitted; relationship to paid leave;
17	sick leave; grandparents. (a) Pursuant to section 398-A, an
18	employee who is a grandparent shall be entitled to one week of
19	family leave. The family leave shall consist of unpaid leave,
20	paid leave, or a combination of paid and unpaid leave. If an
21	employer provides paid family leave for fewer than one week, the

1	additional period of leave added to attain the one-week total
2	may be unpaid.
3	(b) Except as otherwise provided in subsection (c), an
4	employee may elect to substitute any of the employee's accrued
5	paid leaves, including but not limited to vacation, personal, or
6	family leave for any part of the one-week period in subsection
7	<u>(a).</u>
8	(c) An employer who provides sick leave for employees
9	shall permit an employee to use the employee's accrued and
10	available sick leave for purposes of this chapter; provided that
11	an employee covered by this section shall not use more than
12	seven days per year for this purpose, unless an express
13	provision of a valid collective bargaining agreement authorizes
14	the use of more than seven days of sick leave for family leave
15	purposes of this section. Nothing in this section shall require
16	an employer to diminish an employee's accrued and available sick
17	leave below the amount required pursuant to section 392-41;
18	provided that any sick leave in excess of the minimum statutory
19	equivalent for temporary disability benefits as determined by
20	the department may be used for purposes of this chapter."

SECTION 3. Section 398-5, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§398-5 Notice. In any case in which the necessity for 4 family leave for purposes of birth or adoption of a child or 5 providing care to a child, spouse, reciprocal beneficiary, 6 sibling, grandchild, or parent is foreseeable, the employee 7 shall provide the employer with prior notice of the expected 8 birth or adoption or serious health condition in a manner that 9 is reasonable and practicable. Requests for family leave shall 10 include evidence that the employee has submitted the request and 11 provided required data in accordance with section 398-9.5."

SECTION 4. Section 398-6, Hawaii Revised Statutes, isamended by amending subsection (c) to read as follows:

14 "(c) When leave is to care for a child, spouse, reciprocal 15 beneficiary, sibling, <u>grandchild</u>, or parent who has a serious 16 health condition, certification shall be issued by the health 17 care provider of the individual requiring care. Certification 18 shall be considered sufficient if it provides information as 19 required by the director."

20 SECTION 5. Section 398-10, Hawaii Revised Statutes, is
21 amended by amending subsection (a) to read as follows:



1 "(a) [Section] Sections 398-3 and 398-A shall set [a] 2 minimum [standard] standards that [is] are not intended to 3 replace family leave policies that exist as of the effective 4 date of this Act and that provide for equal or greater 5 employment benefits than those benefits afforded under this 6 chapter." 7 SECTION 6. In codifying the new sections added by section 2 of this Act, the revisor of statutes shall substitute 8 9 appropriate section numbers for the letters used in designating 10 the new sections in this Act. 11 SECTION 7. Statutory material to be repealed is bracketed 12 and stricken. New statutory material is underscored. 13 SECTION 8. This Act shall take effect upon its approval.
