A BILL FOR AN ACT

RELATING TO FISCAL BIENNIUM 2019-2021 BUDGET REQUESTS FOR THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. GENERAL PROVISIONS							
2	SECTION 1. The purpose of this Act is to establish							
3	additional amounts to be appropriated or authorized for the							
4	operating budget for the fiscal biennium beginning July 1, 2019,							
5	and ending June 30, 2021, for certain state executive branch							
6	programs under the purview of the house of representatives							
7	standing committee on consumer protection and commerce.							
8	SECTION 2. DEFINITIONS. Unless otherwise clear from the							
9	context, as used in this Act:							
10	"Expending agency" means the department of land and natural							
11	resources.							
12	Abbreviations, where used to denote the expending agency or							
13	a house of representatives standing committee, shall mean the							
14	following:							
15	LNR Department of land and natural resources							

- 1 "Means of financing" or "MOF" means the source from which
- 2 funds are appropriated or authorized to be expended for the
- 3 programs and projects specified in this Act. All appropriations
- 4 are followed by letter symbols. The letter symbols, where used,
- 5 shall have the following meanings:
- 6 B Special funds
- 7 "Program ID" means the unique identifier for the specific
- 8 program and consists of the abbreviation for the organization
- 9 responsible for carrying out the program followed by the
- 10 organization number for the program.
- 11 PART II. PROGRAM APPROPRIATIONS
- 12 SECTION 3. APPROPRIATIONS. The following sums, or so much
- 13 thereof as may be sufficient to accomplish the purposes and
- 14 programs designated herein, are hereby appropriated or
- 15 authorized, as the case may be, from the means of financing
- 16 specified to the expending agency designated for the fiscal
- 17 biennium beginning July 1, 2019, and ending June 30, 2021. The
- 18 total expenditures in each fiscal year of the biennium shall not
- 19 exceed the sums indicated for each fiscal year, except as
- 20 provided elsewhere in this Act or as provided by general law.

7	SECTION 4. If any portion of this Act or its application								
8	to any person, entity, or circumstance is held to be invalid for								
9	any reason, then the legislature declares that the remainder of								
10	this Act and each and every other provision thereof shall not be								
11	affected thereby. If any portion of a specific appropriation is								
12	held to be invalid for any reason, the remaining portion shall								
13	be expended to fulfill the objective of the appropriation to the								
14	extent possible.								
15	SECTION 5. If manifest clerical, typographical, or other								
16	mechanical errors are found in this Act, the governor may								
17	correct the errors.								
18	SECTION 6. This Act shall take effect upon its approval.
