# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES BUDGET.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to provide funding
 for the operations of the department of land and natural
 resources for the fiscal biennium beginning July 1, 2019, and
 ending June 30, 2021.

5 SECTION 2. Unless otherwise clear from the context, as
6 used in this Act:

7 "Expending agency" means the executive department, 8 independent commission, bureau, office, board, or other 9 establishment of the state government (other than the 10 legislature, Office of Hawaiian Affairs, and judiciary), the 11 political subdivisions of the State, or any quasi-public 12 institution supported in whole or in part by state funds, which 13 is authorized to expend specified appropriations made by this 14 Act.

Abbreviations, where used to denote the expending agency,shall mean the following:

1 "Means of financing" or "MOF" means the source from which 2 funds are appropriated or authorized to be expended for the 3 programs and projects specified in this Act. All appropriations 4 are followed by letter symbols. Such letter symbols, where 5 used, shall have the following meanings: 6 Α general funds 7 "Position ceiling" means the maximum number of permanent 8 and temporary full-time equivalent positions authorized for a 9 particular program during a specified period or periods, as 10 denoted by an asterisk for permanent full-time equivalent 11 positions and a pound sign for temporary full-time equivalent 12 positions. 13 "Program ID" means the unique identifier for the specific 14 program and consists of the abbreviation for the organization

15 responsible for carrying out the program followed by the 16 organization number for the program.

SECTION 3. The following sums, or so much thereof as may be sufficient to accomplish the purposes and programs designated herein, are hereby appropriated or authorized, as the case may be, from the means of financing specified to the department of land and natural resources for the fiscal biennium beginning

July 1, 2019, and ending June 30, 2021. The total expenditures
 and the number of positions in each fiscal year of the biennium
 shall not exceed the sums and the position ceilings indicated
 for each fiscal year, except as provided elsewhere in this Act
