A BILL FOR AN ACT

RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to provide funding
- 2 for the operations of the Hawaii public housing authority for
- 3 the fiscal biennium beginning July 1, 2019 and ending June 30,
- 4 2021.
- 5 SECTION 2. Unless otherwise clear from the context, as
- 6 used in this Act:
- 7 "Expending agency" means the executive department,
- 8 independent commission, bureau, office, board, or other
- 9 establishment of the state government (other than the
- 10 legislature, office of Hawaiian affairs, and judiciary), the
- 11 political subdivisions of the State, or any quasi-public
- 12 institution supported in whole or in part by state funds, which
- 13 is authorized to expend specified appropriations made by this
- 14 Act.
- 15 Abbreviations, where used to denote the expending agency,
- 16 shall mean the following:
- 17 HMS Department of Human Services

- 1 "Means of financing" or "MOF" means the source from which
- 2 funds are appropriated or authorized to be expended for the
- 3 programs and projects specified in this Act. All appropriations
- 4 are followed by letter symbols. The letter symbols, where used,
- 5 shall have the following meanings:
- 6 A General funds
- 7 N Federal funds
- 8 W Revolving funds
- 9 "Position ceiling" means the maximum number of permanent
- 10 and temporary full-time equivalent positions authorized for a
- 11 particular program during a specified period or periods, as
- 12 denoted by an asterisk for permanent full-time equivalent
- 13 positions and a pound sign for temporary full-time equivalent
- 14 positions.
- 15 "Program ID" means the unique identifier for the specific
- 16 program and consists of the abbreviation for the organization
- 17 responsible for carrying out the program followed by the
- 18 organization number for the program.
- 19 SECTION 3. The following sums, or so much thereof as may
- 20 be sufficient to accomplish the purposes and programs designated
- 21 herein, are hereby appropriated or authorized, as the case may

- 1 be, from the means of financing specified to the expending
- 2 agencies designated for the fiscal biennium beginning July 1,
- 3 2019 and ending June 30, 2021. The total expenditures and the
- 4 number of positions in each fiscal year of the biennium shall
- 5 not exceed the sums and the position ceilings indicated for each
- 6 fiscal year, except as provided elsewhere in this Act or as
- 7 provided by general law.
