A BILL FOR AN ACT

RELATING TO INSPECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that orderly and
- 2 coordinated inspections of long-term care facilities is in the
- 3 best interests of the public and any potentially-affected
- 4 stakeholders. The legislature further finds that the elderly or
- 5 disabled residents of these long-term care facilities have
- 6 rights to privacy and to be free of unwarranted and unwanted
- 7 government intrusion. The legislature believes that these
- 8 individuals deserve to be treated with respect and granted peace
- 9 and quiet.
- 10 The legislature recognizes that it would be more efficient
- 11 and beneficial for the department of health to spend its
- 12 resources meeting and establishing a dialogue with the operators
- of the affected long-term care facilities, thus creating an
- 14 opportunity for the operators of these facilities to learn from
- 15 the department's inspectors. Further, the legislature notes
- 16 that unannounced inspections are a misuse of State resources

- 1 when the operator of an affected long-term care facility is not
- 2 present for the inspection.
- 3 Accordingly, the purpose of this Act is to require the
- 4 department of health to provide at least two hours notice to
- 5 long-term care facilities prior to unannounced visits and
- 6 inspections.
- 7 SECTION 2. Section 321-1.9, Hawaii Revised Statutes, is
- 8 amended by amending subsection (a) to read as follows:
- 9 "(a) The department of health shall conduct unannounced
- 10 visits and inspections, including inspections for relicensing or
- 11 recertification, for the following state-licensed or state-
- 12 certified care facilities on an annual basis and at such
- 13 intervals as determined by the department to ensure the health,
- 14 safety, and welfare of each resident:
- 15 (1) Adult day health centers;
- 16 (2) Adult day care centers;
- 17 (3) Community care foster family homes;
- 18 (4) Developmental disabilities domiciliary homes;
- 19 (5) Adult foster homes;
- 20 (6) Long-term care facilities, including but not limited
