1 prescribed dosage, or if the student endangers others with the 2 student's medication, inhaler, or auto-injectable epinephrine. 3 For the purposes of this section, the term "inhaler" 4 includes: 5 (1) Metered-dose, breath-actuated, and dry powder 6 inhalers; and 7 (2) Spacers and holding chambers. 8 [(g)] (h) Any employee or agent who volunteers to 9 administer insulin [or], glucagon, seizure medication, or vagus 10 nerve stimulation in an emergency situation to a student with 11 diabetes [or], auto-injectable epinephrine to a student with 12 anaphylaxis, or seizure medication or vagus nerve stimulation to 13 a student with a seizure disorder, or who volunteers to 14 administer or assist a student with blood glucose monitoring 15 shall receive instruction in the proper administration of 16 insulin, glucagon, auto-injectable epinephrine, seizure 17 medication or vagus nerve stimulation, or blood glucose 18 monitoring by a qualified health care professional. A 19 "qualified health care professional" means a licensed physician, 20 physician assistant, advanced practice registered nurse or 21 registered nurse, or certified diabetes educator. The student's

1 parent or quardian shall supply the school with the glucagon kit 2 required to administer the glucagon, any supplies necessary to 3 administer insulin, blood glucose monitoring, or with auto-4 injectable epinephrine supplies to administer epinephrine. The 5 school shall store the glucagon kit, insulin supplies, blood 6 glucose monitoring supplies, seizure medication or vagus nerve 7 stimulation magnet, or auto-injectable epinephrine supplies in a 8 secure but accessible location.

9 [(h)] (i) Any person, except for a qualified health care 10 professional providing the training required in subsection (g), 11 who acts in accordance with the requirements of this section 12 shall be immune from any civil or criminal liability arising 13 from these acts, except where the person's conduct would 14 constitute gross negligence, willful and wanton misconduct, or 15 intentional misconduct."

16 SECTION 5. There is appropriated out of the general 17 revenues of the State of Hawaii the sum of \$100,000 or so much 18 thereof as may be necessary for fiscal year 2020-2021 to train 19 employees to administer or assist with the self-administration 20 of seizure rescue medication at each public school and public 21 charter school.



The sum appropriated shall be expended by the department of
education for the purposes of this Act.
SECTION 6. Statutory material to be repealed is bracketed
and stricken. New statutory material is underscored.
SECTION 7. This Act shall take effect upon its approval;
provided that section 5 shall take effect on July 1, 2020.

Education; Seizure Safe Schools; Seizure Disorder Rescue Medication; School Employee Training; Appropriation

Description:

Requires schools to have an employee trained to administer seizure disorder rescue medication. Exempts schools that do not have a student with a seizure disorder. Requires a seizure action plan for every diagnosed student and distribution of the plan to employees charged with supervising the student. Requires all principals, guidance counselors, and teachers to perform self-review of seizure disorder materials annually. Makes an appropriation. (HB141 HD2 PROPOSED)
