A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	"§302A- Administration of emergency seizure rescue
6	medication; training. (a) Beginning January 1, 2022, each
7	school shall have at least one school employee on duty during
8	the entire school day to administer or assist with:
9	(1) The self-administration of seizure rescue medication
10	or medication prescribed to treat seizure disorder
11	symptoms approved by the United States Food and Drug
12	Administration; and
13	(2) A manual dose of prescribed electrical stimulation
14	using a vagus nerve stimulator magnet, as approved by
15	the United States Food and Drug Administration.
16	(b) The department shall ensure that all personnel
17	assigned to administer or assist with the self-administration o

1	serzure r	escue medication, vagus herve stimulator magnet, or any
2	other med	lication prescribed to treat seizure disorder symptoms
3	are eithe	er trained:
4	(1)	Through a training program adopted by rule in
5		accordance with chapter 91 for the training of school
6		personnel in the health care needs of students
7		diagnosed with a seizure disorder; or
8	(2)	By a physician, advanced practice registered nurse, or
9		physician assistant consistent with best practice
10		guidelines on seizure treatment and the recognition of
11		the signs and symptoms of seizures and the appropriate
12		steps for seizure first aid.
13	(c)	Beginning January 1, 2022, and on an annual basis
14	thereafte	er, all principals, guidance counselors, and teachers
15	employed	by the department shall complete at least one hour of
16	self-stud	dy review of seizure disorder materials developed by
17	medical p	professionals having expertise in seizure treatment and
18	consister	at with best practice guidelines on the recognition of
19	the signs	s and symptoms of seizures and the appropriate steps for
20	seizure f	irst aid.

1	(d) Beginning January 1, 2022, and on an annual basis
2	thereafter, each school shall provide an age appropriate seizure
3	education program to all students on seizures and seizure
4	disorders. The seizure education program shall be consistent
5	with guidelines published by the Epilepsy Foundation or any
6	successor organization.
7	(e) This section shall not apply to any school that does
8	not have at least one student enrolled who has either:
9	(1) A seizure disorder; or
10	(2) A seizure rescue medication or medication prescribed
11	to treat seizure disorder symptoms approved by the
12	United States Food and Drug Administration prescribed
13	by the student's health care provider."
14	SECTION 2. Chapter 302D, Hawaii Revised Statutes, is
15	amended by adding a new section to be appropriately designated
16	and to read as follows:
17	"§302D- Administration of emergency seizure rescue
18	medication; training. (a) Beginning January 1, 2022, each
19	public charter school shall have at least one school employee on
20	duty during the entire school day to administer or assist with:

1	<u>(1)</u>	The self-administration of seizure rescue medication
2		or medication prescribed to treat seizure disorder
3		symptoms approved by the United States Food and Drug
4		Administration; and
5	(2)	A manual dose of prescribed electrical stimulation
6		using a vagus nerve stimulator magnet as approved by
7		the United States Food and Drug Administration.
8	(b)	The public charter school shall ensure that all
9	personnel	assigned to administer or assist with the self-
10	administr	ation of seizure rescue medication, vagus nerve
11	stimulato	r magnet, or any other medication prescribed to treat
12	seizure d	isorder symptoms are trained by a physician, advanced
13	practice	registered nurse, or physician assistant consistent
14	with best	practice guidelines on seizure treatment and the
15	recogniti	on of the signs and symptoms of seizures and the
16	appropria	te steps for seizure first aid.
17	(c)	Beginning January 1, 2022, and on an annual basis
18	thereafte	r, all principals, guidance counselors and teachers
19	employed :	by the public charter school shall complete at least
20	one hour	of self-study review of seizure disorder materials
21	developed	by medical professionals having expertise in seizure

1	treatment and consistent with best practice guidelines on the
2	recognition of the signs and symptoms of seizures and the
3	appropriate steps for seizure first aid.
4	(d) In the case of any student who is certified by the
5	student's physician, advanced practice registered nurse, or
6	physician assistant as having a seizure disorder, the public
7	charter school shall establish a seizure action plan for that
8	student, in conjunction with the student's parent or guardian,
9	that shall include but not be limited to the identification of
10	the employee or employees trained to assist the student in the
11	event of a seizure and the method by which the trained employee
12	or employees are contacted in the event of the seizure. The
13	seizure action plan shall be:
14	(1) Distributed to every school employee or volunteer
15	responsible for the supervision or care of the student
16	diagnosed with a seizure disorder; and
17	(2) Kept on file at the school at which the student is
18	enrolled.
19	(e) Beginning January 1, 2022, and on an annual basis
20	thereafter, each public charter school shall provide an age

appropriate seizure education program to all students on

1	seizures and seizure disorders. The seizure education program
2	shall be consistent with guidelines published by the Epilepsy
3	Foundation or any successor organization.
4	(f) This section shall not apply to any public charter
5	school that does not have at least one student enrolled who has
6	either:
7	(1) A seizure disorder; or
8	(2) A seizure rescue medication or medication prescribed
9	to treat seizure disorder symptoms approved by the
10	United States Food and Drug Administration prescribed
11	by the student's health care provider."
12	SECTION 3. Section 302A-1164, Hawaii Revised Statutes, is
13	amended to read as follows:
14	"§302A-1164 Self-administration of medication by student
15	and emergency administration[; self-testing and self-management
16	of diabetes by student; assistance with diabetes testing; blood
17	glucose monitoring by student; assistance with blood glucose
18	<pre>monitoring; permitted. (a) The department shall permit:</pre>

(1) The self-administration of:

19	(b)	The	student's parent or guardian shall provide the
20	department	. wit	ch:

1	(1)	Written authorization for the self-administration of
2		medication or the emergency administration of glucagon
3		[or] auto-injectable epinephrine[+], seizure
4		medications, or vagus nerve stimulator magnet;
5	(2)	In the case of self-administration of medication:
6		(A) Written certification from the student's
7		physician, advanced practice registered nurse, or
8		physician assistant stating that the student with
9		diabetes may perform the student's own blood
10		glucose checks, administer insulin through the
11		student's insulin delivery system, and otherwise
12		attend to the care and management of the
13		student's diabetes during any school-related
14		activity, and that the student may possess on the
15		student's person all necessary supplies and
16		equipment to perform the diabetes monitoring and
17		treatment activities, if applicable; and
18		(B) Written certification from the student's
19		physician, advanced practice registered nurse, or
20		physician assistant stating that the student:

1		(i) Has asthma, anaphylaxis, seizure disorder,
2		or another potentially life-threatening
3		illness; and
4		(ii) Is capable of, and has been instructed in,
5		the proper method of self-administration of
6		medication or blood glucose monitoring; and
7	(3)	In the case of administration of insulin or emergency
8		administration of glucagon to a student with diabetes,
9		blood glucose monitoring of a student, [ex] auto-
10		injectable epinephrine to a student with anaphylaxis,
11		or administration of seizure medication or vagus nerve
12		stimulation to the student having a seizure disorder,
13		written certification from the student's physician,
14		advanced practice registered nurse, or physician
15		assistant stating that the student has medical orders
16		that insulin, glucagon, blood glucose monitoring, [or]
17		auto-injectable epinephrine, seizure medication, or
18		vagus nerve stimulation may be administered by a
19		volunteer.
20	<u>(c)</u>	In the case of any student who is certified by the
21	student's	physician, advanced practice registered nurse, or

- physician assistant as having a seizure disorder, the department
 shall establish a seizure action plan for that student, in
- 3 conjunction with the student's parent or guardian, that shall
- 4 include but not be limited to the identification of the school
- 5 employee or employees trained to assist the student in the event
- 6 of a seizure and the method by which the trained employee or
- 7 employees are to be contacted in the event of the seizure.
- The seizure action plan shall be:

1	(1)	The department and its employees or agents shall not
2		incur any liability as a result of any injury arising
3		from compliance with this section; and
4	(2)	The parent or guardian shall indemnify and hold
5		harmless the department and its employees or agents
6		against any claims arising out of compliance with this

8	[(e)] (f) The permission shall be effective for the school
9	year for	which it is granted and shall be renewed for each
10	subsequen	t school year upon the fulfillment of the requirements
11	in this s	ection.
12	[(£)] (g) Notwithstanding any other law to the contrary, a
13	student w	ho is permitted to self-administer medication under
14	this sect	ion shall be permitted to carry an inhaler or
15	auto-inje	ctable epinephrine, or both, at all times if the
16	student d	oes not endanger the student's person or other persons
17	through t	he misuse of the inhaler; provided that the department,
18	its emplo	yees or agents may confiscate a student's medication,
19	inhaler,	or auto-injectable epinephrine if the student's
20	self-admi	nistration of the medication exceeds the student's

- 1 prescribed dosage, or if the student endangers others with the
- 2 student's medication, inhaler, or auto-injectable epinephrine.
- For the purposes of this section, the term "inhaler"
- 4 includes:
- 5 (1) Metered-dose, breath-actuated, and dry powder
- 6 inhalers; and
- 7 (2) Spacers and holding chambers.
- 8 [(g)] (h) Any employee or agent who volunteers to
- 9 administer insulin or glucagon in an emergency situation to a
- 10 student with diabetes [or], auto-injectable epinephrine to a
- 11 student with anaphylaxis, or seizure medication or vagus nerve
- 12 stimulation to a student having a seizure disorder, or who
- 13 volunteers to administer or assist a student with blood glucose
- 14 monitoring shall receive instruction in the proper
- 15 administration of insulin, glucagon, auto-injectable
- 16 epinephrine, seizure medication or vagus nerve stimulation, or
- 17 blood glucose monitoring by a qualified health care
- 18 professional. A "qualified health care professional" means a
- 19 licensed physician, physician assistant, advanced practice
- 20 registered nurse or registered nurse, or certified diabetes
- 21 educator. The student's parent or guardian shall supply the

- 1 school with the glucagon kit required to administer the
- 2 glucagon, any supplies necessary to administer insulin, blood
- 3 glucose monitoring, or with auto-injectable epinephrine supplies
- 4 to administer epinephrine. The school shall store the glucagon
- 5 kit, insulin supplies, blood glucose monitoring supplies,
- 6 seizure medication or vagus nerve stimulator magnet, or auto-
- 7 injectable epinephrine supplies in a secure but accessible
- 8 location.
- 9 [\(\frac{(h)}{l}\)] (i) Any person, except for a qualified health care
- 10 professional providing the training required in subsection
- 11 $\left[\frac{q}{r}\right]$ (h), who acts in accordance with the requirements of this
- 12 section shall be immune from any civil or criminal liability
- 13 arising from these acts, except where the person's conduct would
- 14 constitute gross negligence, willful and wanton misconduct, or
- 15 intentional misconduct."
- 16 SECTION 4. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2020-2021 to
- 19 train employees to administer or assist with the self-
- 20 administration of seizure rescue medication at each public
- 21 school and public charter school.

- 1 The sum appropriated shall be expended by the department of
- 2 education for the purposes of this Act.
- 3 SECTION 5. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 6. This Act shall take effect on July 1, 2030.

Education; Seizure Safe Schools; Seizure Disorder Rescue Medication; School Employee Training; Appropriation

Description:

Requires public schools and public charter schools to have an employee trained to administer seizure disorder rescue medication. Exempts schools that do not have a student with a seizure disorder. Requires a seizure action plan for every diagnosed student and distribution of the plan to employees charged with supervising the student. Requires all principals, guidance counselors, and teachers to perform self-review of seizure disorder materials annually. Makes an appropriation. Effective July 1, 2030. (HD3)
