## A BILL FOR AN ACT

RELATING TO VISITOR INFORMATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature recognizes that tourism is the SECTION 1. 2 State's leading industry. According to the department of 3 business, economic development, and tourism, the primary source 4 of income for Hawaii is the visitor sector, which spreads itself 5 over several industries such as service, transportation, and 6 retail trade. The legislature finds that the Capitol district 7 located in Honolulu is a historical, cultural, educational, and 8 recreational hub for visitors and residents.

9 Each year, the Capitol district draws many visitors to see
10 and experience the historical sites and attractions in the area,
11 including the State Capitol, Iolani Palace, Washington Place,
12 Honolulu Hale, Kawaiaha'o church, Hawaii state art museum, Queen
13 Lili'uokalani statue, and Father Damien statue, among others.

14 The legislature finds that a visitor information center 15 located in the State Capitol would serve as a reliable and 16 informative resource for informing and educating visitors about 17 local areas and attractions, lodging, maps, transportation

1	routes, and other services; promoting the State's tourist

4	SECTION 2. The Hawaii Revised Statutes is amended by
5	adding a new chapter to be appropriately designated and to read
6	as follows:
7	"CHAPTER
8	VISITOR INFORMATION CENTER AND PROGRAM
9	<b>§ -1 Purpose.</b> The purpose of this chapter is to
10	establish a permanent visitor information center program to
11	support the visitor experience in the State and to assist
12	visitors and other members of the public in their enjoyment of
13	the historical, cultural, educational, and recreational
14	resources of the Capitol district, its surrounding areas, and
15	the State.
16	§ -2 Visitor information center; established. There is
17	established in the state capitol a visitor information center to
18	serve as a permanent source for informing and educating visitors
19	about local areas and attractions, lodging, transportation, and
20	other services; promoting the State's tourist attractions,

 information service to residents.

3 § -3 Visitor information center program; established.
4 (a) There is established in the state capitol a visitor
5 information center program that shall become part of the
6 legislature's permanent visitor information center program.

7 (b) The visitor information center program shall be
8 supervised by the joint legislative access committee established
9 pursuant to section 21D-6."

10 SECTION 3. Section 21D-6, Hawaii Revised Statutes, is 11 amended to read as follows:

12 "[4] §21D-6 Joint legislative access committee.[4] There
13 is established the joint legislative access committee which
14 shall be composed of members of the legislature. The president
15 of the senate and the speaker of the house of representatives
16 shall each appoint a co-chair and two members or more to the
17 committee, one of whom shall be a member of the minority party.
18 The committee shall:

19 20 (1) Oversee the staff and operations of the legislative broadcast project, and recommend policies for the

1		project which shall be adopted by concurrent

3	(2)	Oversee the staff and operations of the visitor
4		information center, and recommend policies for the

6		adopted by concurrent resolution; and
7	[ <del>(2)</del> ]	(3) Review the operations of the public access room,
8		legislative internet project, and other public access
9		projects of the legislature and recommend policies for
10		these projects to the president of the senate and the
11		speaker of the house of representatives."
12	SECT	ION 4. There is appropriated out of the general
13	revenues	of the State of Hawaii the sum of \$ or so much
14	thereof a	s may be necessary for fiscal year 2019-2020 and the
15	sum of \$	or so much thereof as may be necessary for
16	fiscal ye	ar 2020-2021 for the purposes of this Act.
17	The	sums appropriated shall be expended by the senate for
18	the purpo	ses of this Act.
19	SECT	ION 5. There is appropriated out of the general
20	revenues	of the State of Hawaii the sum of \$ or so much
21	thereof a	s may be necessary for fiscal year 2019-2020 and the

sum of \$ or so much thereof as may be necessary for
 fiscal year 2020-2021 for the purposes of this Act.
 The sums appropriated shall be expended by the house of
 representatives for the purposes of this Act.
 SECTION 6. Statutory material to be repealed is bracketed
 and stricken. New statutory material is underscored.
 SECTION 7. This Act shall take effect on July 1, 2022.
