A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 321, Hawaii Revised Statutes, is
2	amended by adding a new part to be appropriately designated and
3	to read as follows:
4	"PART . CALORIE INFORMATION
5	§321-A Definitions. As used in this part:
6	"Food service establishment":
7	(1) Means, but is not limited to, restaurants and food
8	concessions within the State that:
9	(A) Operate under common ownership or control with at
10	least fifteen other food service establishments
11	doing business nationally; or
12	(B) Operate as a franchised outlet of a parent
13	business or under the same name as at least
14	fifteen other food service establishments doing
15	business nationally; and

1	offer for sale substantially the same menu items in
2	servings that are standardized for portion size and
3	content.
4	2) Does not include farmers markets, commissaries,
5	licensed health care facilities, public and private

7	"Food item tag" means a label or tag that identifies food
8	items displayed for sale at a food service establishment and
9	their prices.
10	"Menu" means a list or pictorial display of food items and
11	prices.
12	"Menu board" means a list or pictorial display of food
13	items and prices posted in and visible within a food service
14	establishment or outside of a food service establishment for the
15	purpose of ordering from a drive-through window.
16	"Standard menu item" means individual food items or
17	combinations of food items listed or displayed on a menu or menu
18	board that are sold in servings that are standardized for
19	portion size and content.
20	§321-B Calorie information for menu items. (a) All menus
21	and menu boards at a food service establishment shall provide

- 1 the total number of calories for each standard menu item listed.
- 2 The calorie information shall be displayed clearly and
- 3 conspicuously, adjacent or in close proximity to the menu item,
- 4 and in a font or format that is at least as prominent in size
- 5 and appearance as that used to post the name and price of the
- 6 menu item. The calorie information shall be visible at or prior
- 7 to the point of ordering.
- **8** (b) Standard menu items displayed for sale with a food
- 9 item tag shall provide the calorie information on the food item
- 10 tag in a font size and format at least as prominent as the font
- 11 size of the name and price of the food item.
- (c) Calorie content values at drive-through windows shall
- 13 be displayed on either the drive through menu board, or on an
- 14 adjacent stanchion visible at or prior to the point of ordering,
- 15 so long as the calorie content values are as clearly and
- 16 conspicuously posted on the stanchion adjacent to their
- 17 respective menu item names, as the price or menu item is on the
- 18 drive through menu board.
- 19 (d) This section shall not apply to standard menu items
- 20 offered for sale for less than thirty days in a calendar year.

- 1 §321-C Calculation of calories. (a) Calorie content
- 2 values shall be based upon a verifiable analysis of the standard
- 3 menu item that may include the use of nutrient databases,
- 4 laboratory testing, or other reliable methods of analysis, and
- 5 shall be rounded to the nearest ten calories for calorie content
- 6 values above fifty calories and to the nearest five calories for
- 7 calorie content values fifty calories and below.
- 8 (b) For standard menu items offered in different flavors
- 9 and varieties, including but not limited to beverages, ice
- 10 cream, pizza, and doughnuts, the range of calorie content values
- 11 showing the minimum to maximum number of calories for all
- 12 flavors and varieties of that item shall be listed on menu
- 13 boards and menus for each size offered for sale; provided that
- 14 the range need not be displayed if the calorie information is
- 15 included on the food item tag identifying each flavor or variety
- 16 of the food item displayed for sale, in accordance with section
- **17** 321-B.
- 18 (c) For combinations of different food items listed or
- 19 pictured as a single menu item, the range of calorie content
- 20 values showing the minimum to maximum number of calories for all
- 21 combinations of that menu item shall be listed on menu boards

- 1 and menus. If there is only one possible calorie total for the
- 2 combination, then that total shall be listed on menu boards and
- 3 menus."
- 4 SECTION 2. In codifying the new sections added by section
- 5 1 of this Act, the revisor of statutes shall substitute
- 6 appropriate section numbers for the letters used in designating
- 7 the new sections in this Act.
- 8 SECTION 3. This Act shall take effect upon its approval.
