### A BILL FOR AN ACT

RELATING TO HEALTH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that existing state law 2 regulates home care services provided by home care agencies, but 3 does not regulate personal care services provided by 4 individuals. The legislature further finds that, in Hawaii, 5 there are more individuals providing personal care services to 6 residents than any other form of care, including home health 7 services and home care services. The legislature also finds 8 that Hawaii residents want to hire individual personal 9 caregivers to provide personal care services to their loved ones 10 in their homes. These services may include assistance with 11 regular daily activities, as well as skilled nursing services 12 like medication administration and wound care. Unfortunately, 13 most individual personal caregivers work without any 14 supervision, making Hawaii's elderly population and other 15 persons requiring personal care services potentially vulnerable 16 to receiving improper care services.

1	The legislature finds that the administration of individual
2	personal care services is vital and necessary when a person
3	requiring care prefers to remain in the person's residence.
4	However, in order to promote public health and welfare,
5	individuals providing care should be supervised by registered
6	nurses acting as case managers.
7	The purpose of this Act is to protect Hawaii's seniors and
8	other persons that need home-based personal care by requiring
9	the department of health to regulate individual personal
10	caregivers and requiring the supervision of such individuals by
11	registered nurses acting as case managers.
12	SECTION 2. Chapter 321, Hawaii Revised Statutes, is
13	amended by adding a new section to be appropriately designated
14	and to read as follows:
15	" <u>§321- Individual personal care providers.</u> (a) An
16	individual who is not licensed by the department may provide
17	personal care services in this State only if the individual
18	meets the requirements of this section.
19	(b) An individual personal caregiver who is not employed
20	by a home care agency may provide personal care services outside

21 of a regulated facility only under the supervision of a nurse

5	(c)	Each nurse case manager shall provide the following
6	informati	on to the department on a monthly basis:
7	(1)	The name of each individual personal caregiver
8		supervised by the nurse case manager; and
9	(2)	Subject to the Health Insurance Portability and
10		Accountability Act of 1996, P.L. 104-191, and title 45
11		Code of Federal Regulations part 164, the name and
12		address of each service recipient.
13	(d)	Each nurse case manager shall:
14	(1)	Ensure that each individual personal caregiver
15		providing personal care services under the nurse case
16		manager's supervision:
17		(A) Is certified in first aid and cardiopulmonary
18		resuscitation;
19		(B) Obtains a tuberculosis clearance certificate
20		prior to providing personal care services and

1			thereafter obtains an annual tuberculosis
2			clearance certificate;
3		(C)	Has completed a background check substantially
4			similar to the background check required in
5			section 321-15.2, to the extent permitted under
6			applicable law, and has no disqualifying
7			information, as defined in section 321-15.2, or
8			other background check information that the nurse
9			case manager finds may pose a risk to the health,
10			safety, or welfare of service recipients; and
11		(D)	Has completed a course of instruction on
12	(3)		medication conducted by the nurse case manager;
13	(2)	Ensu	re that each residence where personal care
14		serv	ices are provided by an individual personal
15		care	giver under the nurse case manager's supervision:
16		(A)	Has been inspected by the nurse case manager
17			within the preceding twelve months and is
18			suitable for the personal care services to be
19			administered;
20		<u>(B)</u>	Is not the residence of any individual personal
21			caregiver under the nurse case manager's

2			the residence; and
3		<u>(C)</u>	Is not owned by any individual personal caregiver
4			under the nurse case manager's supervision
5			providing personal care services at the residence
6			or by the spouse of the individual personal
7			caregiver; and
8	(3)	Main	tain written records in compliance with the
9		requ	irements of this subsection, which shall be
10		subj	ect to inspection by the department upon at least
11		fort	y-eight hours' prior written request.
12	<u>(e)</u>	Each	nurse case manager shall obtain and maintain
13	professio	nal l	iability insurance with respect to the nurse case
14	manager's	supe	rvision of individual personal caregivers under
15	this sect	ion w	ith limits of no less than \$1,000,000 per
16	occurrenc	e and	\$5,000,000 in the aggregate; provided that the
17	director	may a	dopt rules pursuant to chapter 91 to establish
18	different	mini	mum coverage limits as appropriate. Each nurse
19	case mana	ger s	hall provide proof of such insurance to the
20	departmen	t on	an annual basis.



1	(f) The care and supervision provided by nurse case
2	managers under this section shall be subject to exclusive
3	regulation by the board pursuant to chapter 457. The board
4	shall adopt rules pursuant to chapter 91 to carry out the
5	purposes of this section.
6	(g) An organization that provides referrals to individual
7	personal caregivers or to nurse case managers, or that
8	promulgates voluntary standards of practice and care for
9	individual personal caregivers or nurse case managers, shall not
10	be required to be licensed by the department; provided that the
11	organization charges fees to individual personal caregivers,
12	nurse case managers, or service recipients based upon the number
13	of such referrals.
14	(h) The director may impose an administrative fine on any
15	person that violates this section or rule adopted pursuant to
16	this section after notice and opportunity for an administrative
17	hearing held in accordance with chapter 91. The fine shall not
18	exceed \$ ; provided that the fine for any violation
19	occurring within five years of a prior violation shall not
20	exceed \$ .



1	(i) The director may apply for an injunction in any court
2	of competent jurisdiction to enjoin any person from providing
3	personal care services in violation of this section. Upon the
4	filing of a verified petition in the court, the court or any
5	judge thereof, if satisfied by affidavit or otherwise, may issue
6	a temporary injunction, without notice or bond, enjoining the
7	individual personal caregiver from providing further personal
8	care services in violation of this section. A copy of the
9	verified complaint shall be served upon the individual personal
10	caregiver, and the proceedings shall thereafter be conducted
11	pursuant to civil procedure. If it is established that the
12	individual personal caregiver has been or is providing personal
13	care services in violation of this section, the court or judge
14	may enter a decree enjoining the person from further providing
15	personal care services in violation of this section. In the
16	event the injunction is breached, the court may summarily try
17	and impose penalties for contempt of court. The injunction
18	proceeding shall be in addition to, and not in lieu of, fines
19	and other remedies provided in this section.
20	(j) This section shall not apply to home care services
01	

21 provided in a regulated facility or by a home care agency, an

2	compensation, an individual providing personal care services to
3	a grandparent, parent, sibling, spouse, or reciprocal
4	beneficiary, child, grandchild, aunt, uncle, cousin, legal
5	guardian, or a practitioner of medicine or surgery licensed
6	under section 453-2.
7	(k) As used in this section, unless the context otherwise
8	requires:
9	"Board" means the state board of nursing.
10	"Department" means the department of health.
11	"Director" means the director of health.
12	"Individual personal caregiver" means an individual who
13	receives compensation for providing personal care services under
14	this section.
15	"Nurse case manager" means a registered nurse who
16	supervises individual personal caregivers as provided in this
17	section.
18	"Personal care services" means services including but not
19	limited to assistance with dressing, feeding, and personal
20	hygiene, performing chores, housekeeping, shopping, meal
21	planning and preparation, respite care services, and skilled



1	nursing services, such as medication administration and wound
2	care, performed on behalf of a service recipient who desires or
3	requires such services due to advanced age, disability, injury,
4	or illness.
5	"Registered nurse" means an individual licensed as a
6	registered nurse under chapter 457.
7	"Regulated facility" means an adult day health center,
8	adult day care center, community care foster family home,
9	developmental disabilities domiciliary home, adult foster home,
10	special treatment facility, adult residential care home,
11	expanded adult residential care home, assisted living facility,
12	intermediate care facility, nursing facility, skilled nursing
13	facility, or long-term care facility.
14	"Residence" means the premises in which a service recipient
15	resides, which may be owned, leased, or rented by the service
16	recipient, or by a responsible relative or other adult. This
17	term shall not include a regulated facility.
18	"Service recipient" means an individual receiving personal
19	care services under this section."
20	SECTION 3. New statutory material is underscored.

### Report Title:

Department of Health; Individual Personal Caregiver; Registered Nurse; Residential Personal Care Services
