### A BILL FOR AN ACT

RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 206E, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . STADIUM DEVELOPMENT DISTRICT
- 5 §206E- Stadium development district; purpose; findings.
- 6 The legislature finds that the aloha stadium and lands under the
- 7 jurisdiction of the stadium authority and department of
- 8 accounting and general services are underutilized. The stadium
- 9 facility has been in dire need of significant repair and
- 10 maintenance for many years. The stadium authority has
- 11 considered repairing, upgrading, and replacing the existing
- 12 facility to optimize the public's enjoyment and ensure public
- 13 safety. Redeveloping, renovating, or improving these public
- 14 lands in a manner that will provide suitable recreational,
- 15 residential, educational, and commercial areas where the public
- 16 can live, congregate, recreate, attend schools, and shop as part

- 1 of a thoughtfully integrated experience, is in the best
- 2 interests of the State and its people.
- 3 This part establishes the stadium development district to
- 4 make optimal use of public land for the economic, residential,
- 5 educational, and social benefit of the people of Hawaii.
- 6 The legislature finds that the jurisdiction of the Hawaii
- 7 community development authority shall include development within
- 8 the stadium development district. Any development within the
- 9 district shall require a permit from the authority.
- 10 §206E- Definitions. As used in this part, unless the
- 11 context otherwise requires:
- 12 "District" means the stadium development district
- 13 established by this part.
- 14 §206E- District; established; authority's duties within
- 15 the district. (a) The stadium development district is
- 16 established and shall be composed of all land under the
- 17 jurisdiction of the stadium authority established pursuant to
- 18 section 109-1.
- 19 (b) The authority shall facilitate the development of all
- 20 property belonging to the State within the district; provided
- 21 that development is carried out in accordance with any county

9		and other activities the authority deems necessary to
10		carry out development of the district and implement
11		this part. The authority may undertake studies or
12		coordinating activities in conjunction with the count

16	(5)	Hawaiian archaeological, historic, and cultural sites
17		shall be preserved and protected;
18	(6)	Endangered species of flora and fauna shall be
19		preserved as required by state and federal law;

21		district shall be coordinated with and, to the extent

9	SECT	ION 2. There is appropriated out of the general	
10	revenues of the State of Hawaii the sum of \$50,000,000 or so		
11	much ther	eof as may be necessary for fiscal year 2019-2020 for	
12	the estab	lishment and development of the stadium development	
13	district	for public use.	
14	The	sum appropriated shall be expended by the Hawaii	
15	community	development authority for the purposes of this Act;	
16	provided	that the appropriation shall not lapse at the end of	
17	the fisca	l year for which the appropriation is made; provided	
18	further t	hat all moneys unencumbered as of June 30, 2022, shall	
19	lapse as	of that date.	
20	SECT	ION 3. The legislature finds and declares that the	
21	issuance	of revenue bonds pursuant to part III, chapter 39,	

- 1 Hawaii Revised Statutes, under this Act is in the public
- 2 interest and for the public health, safety, and general welfare.
- 3 Accordingly, the Hawaii community development authority, with
- 4 the approval of the governor, may issue in one or more series
- 5 revenue bonds in a total amount not to exceed \$150,000,000 for
- 6 the Hawaii community development authority to implement the
- 7 stadium development district and build a new stadium as provided
- 8 for in part , chapter 206E, Hawaii Revised Statutes.
- 9 The proceeds of the revenue bonds shall be deposited into
- 10 the Hawaii community development revolving fund created in
- 11 section 206E-16, Hawaii Revised Statutes.
- 12 The revenue bonds authorized under this Act shall be issued
- 13 pursuant to part III, chapter 39, Hawaii Revised Statutes. The
- 14 authorization to issue revenue bonds under this Act shall lapse
- 15 on June 30, 2024.
- 16 SECTION 4. The director of finance is authorized to issue
- 17 general obligation bonds in the sum of \$150,000,000 or so much
- 18 thereof as may be necessary and the same sum or so much thereof
- 19 as may be necessary is appropriated for fiscal year 2019-2020 to
- 20 the Hawaii community development authority to build a new
- 21 stadium.

- 4 SECTION 8. This Act shall take effect on January 1, 2050.
