A BILL FOR AN ACT

RELATING TO THE HAWAII STATE PUBLIC LIBRARY SYSTEM BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. GENERAL PROVISIONS						
2	SECTION 1. The purpose of this Act is to establish						
3	additional amounts to be appropriated or authorized and						
4	additional positions in the operating budget for the fiscal						
5	biennium beginning July 1, 2019, and ending June 30, 2021, for						
6	Hawaii state public library system.						
7	SECTION 2. Unless otherwise clear from the context, as						
8	used in this Act:						
9	"Expending agency" means the department of education.						
10	Abbreviations, where used to denote the expending agency or						
11	a house of representatives standing committee, shall mean the						
12	following:						
13	EDN Department of education						
14	"Means of financing" or "MOF" means the source from which						
15	funds are appropriated or authorized to be expended for the						
16	programs and projects specified in this Act. All appropriations

- 2 shall have the following meanings:
- 3 A General funds
- 4 "Position ceiling" means the maximum number of permanent
- 5 and temporary full-time equivalent positions authorized for a
- 6 particular program during a specified period or periods, as
- 7 denoted by an asterisk for permanent full-time equivalent
- 8 positions and a pound sign for temporary full-time equivalent
- 9 positions.
- 10 "Program ID" means the unique identifier for the specific
- 11 program and consists of the abbreviation for the organization
- 12 responsible for carrying out the program followed by the
- 13 organization number for the program.
- 14 PART II. PROGRAM APPROPRIATIONS
- 15 SECTION 3. The following sums, or so much thereof as may
- 16 be sufficient to accomplish the purposes and programs designated
- 17 herein, are hereby appropriated or authorized, as the case may
- 18 be, from the means of financing specified to the expending
- 19 agencies designated for the fiscal biennium beginning July 1,
- 20 2019, and ending June 30, 2021. The total expenditures and the
- 21 number of positions in each fiscal year of the biennium shall

- 1 not exceed the sums and the position ceilings indicated for each
- 2 fiscal year, except as provided elsewhere in this Act or as
- 3 provided by general law.

1 PART III. MISCELLANEOUS AND EFFECTIVE DATE

- 2 SECTION 4. If any portion of this Act or its application
- 3 to any person, entity, or circumstance is held to be invalid for
- 4 any reason, then the legislature declares that the remainder of
- 5 the Act and each and every other provision thereof shall not be
- 6 affected thereby. If any portion of a specific appropriation is
- 7 held to be invalid for any reason, the remaining portion shall
- 8 be expended to fulfill the objective of the appropriation to the
- 9 extent possible.
- 10 SECTION 5. If manifest clerical, typographical, or other
- 11 mechanical errors are found in this Act, the governor may
- 12 correct the errors.
- 13 SECTION 6. This Act shall take effect on July 1, 2055.
