A BILL FOR AN ACT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. GENERAL PROVISIONS
2	SECTION 1. The purpose of this Act is to establish
3	additional amounts to be appropriated or authorized for the
4	operating budget for the fiscal biennium beginning July 1, 2019,
5	and ending June 30, 2021, for The Executive Office on Early
6	Learning Budget.
7	SECTION 2. DEFINITIONS. Unless otherwise clear from the
8	context, as used in this Act:
9	"Expending agency" means the department of education.
10	Abbreviations, where used to denote the expending agency or
11	a house of representatives standing committee, shall mean the

16	"Means of financing" or "MOF" means the source from which
17	funds are appropriated or authorized to be expended for the

- 1 programs and projects specified in this Act. All appropriations
- 2 are followed by letter symbols. The letter symbols, where used,
- 3 shall have the following meanings:
- 4 A General funds
- 5 "Program ID" means the unique identifier for the specific
- 6 program and consists of the abbreviation for the organization
- 7 responsible for carrying out the program followed by the
- 8 organization number for the program.
- 9 PART II. PROGRAM APPROPRIATIONS
- 10 SECTION 3. APPROPRIATIONS. The following sums, or so much
- 11 thereof as may be sufficient to accomplish the purposes and
- 12 programs designated herein, are hereby appropriated or
- 13 authorized, as the case may be, from the means of financing
- 14 specified to the expending agencies designated for the fiscal
- 15 biennium beginning July 1, 2019, and ending June 30, 2021. The
- 16 total expenditures in each fiscal year of the biennium shall not
- 17 exceed the sums indicated for each fiscal year, except as
- 18 provided elsewhere in this Act or as provided by general law.

1 PART III. MISCELLANEOUS AND EFFECTIVE DATE

- 2 SECTION 4. If any portion of this Act or its application
- 3 to any person, entity, or circumstance is held to be invalid for
- 4 any reason, then the legislature declares that the remainder of
- 5 the Act and each and every other provision thereof shall not be
- 6 affected thereby. If any portion of a specific appropriation is
- 7 held to be invalid for any reason, the remaining portion shall
- 8 be expended to fulfill the objective of the appropriation to the
- 9 extent possible.
- 10 SECTION 5. If manifest clerical, typographical, or other
- 11 mechanical errors are found in this Act, the governor may
- 12 correct the errors.
- 13 SECTION 6. This Act shall take effect on July 1, 2019.
