PART I. GENERAL PROVISIONS

SECTION 1. The purpose of this Act is to establish additional amounts to be appropriated or authorized for the operating budget for the fiscal biennium beginning July 1, 2019, and ending June 30, 2021, for the executive office on early learning budget.

PART II. PROGRAM APPROPRIATIONS

9 SECTION 3. The following sums, or so much thereof as may be sufficient to accomplish the purposes and programs designated 10 herein, are hereby appropriated or authorized, as the case may 11 be, from the means of financing specified to the expending 12 13 agencies designated for the fiscal biennium beginning July 1, 2019, and ending June 30, 2021. The total expenditures in each 14 fiscal year of the biennium shall not exceed the sums indicated 15 for each fiscal year, except as provided elsewhere in this Act 16 17 or as provided by general law.

1 PART III. MISCELLANEOUS AND EFFECTIVE DATE 2 SECTION 4. If any portion of this Act or its application 3 to any person, entity, or circumstance is held to be invalid for 4 any reason, then the legislature declares that the remainder of 5 the Act and each and every other provision thereof shall not be 6 affected thereby. If any portion of a specific appropriation is 7 held to be invalid for any reason, the remaining portion shall be expended to fulfill the objective of the appropriation to the 8 9 extent possible. 10 SECTION 5. If manifest clerical, typographical, or other 11 mechanical errors are found in this Act, the governor may 12 correct the errors. 13 SECTION 6. This Act shall take effect on July 1, 2030. 14
