A BILL FOR AN ACT

RELATING TO STUDENT JOURNALISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act shall be known as the "Hawaii Student
 Free Expression Act".

3 SECTION 2. The legislature finds that states may enhance 4 the protections guaranteed by the First Amendment of the United 5 States Constitution through state laws and regulations. The 6 legislature further finds that student journalists attending 7 Hawaii public schools need additional protection against 8 censorship.

9 The purpose of this Act is to establish the Hawaii Student 10 Free Expression Act to allow student journalists at public 11 schools to exercise freedom of speech and freedom of the press 12 in school-sponsored media.

13 SECTION 3. Chapter 302A, Hawaii Revised Statutes, is
14 amended by adding a new section to part II to be appropriately
15 designated and to read as follows:

16 "<u>§302A-</u> School-sponsored media; student journalists.
17 (a) As used in this section:
