A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many of the
- 2 individuals at the State's overcrowded community correctional
- 3 facilities have violated probation, parole, or furlough by use
- 4 of illicit substances and are in need of substance abuse
- 5 treatment and mental health services.
- 6 The legislature further finds that the department of public
- 7 safety is statutorily required pursuant to section 353-10.5,
- 8 Hawaii Revised Statutes, to implement alternative programs that
- 9 place, control, supervise, and treat selected offenders in lieu
- 10 of incarceration.
- 11 The legislature further finds that the department of public
- 12 safety has available space at Halawa valley for the new Oahu
- 13 community correctional center to also accommodate a minimum-
- 14 security facility to house up to four hundred fifty short-term
- 15 adult offenders. The purpose of the minimum-security facility
- 16 shall be to alleviate the overcrowded conditions of the State's
- 17 community correctional facilities and to provide much-needed

- 1 substance abuse treatment and support services, cognitive
- 2 behavioral intervention, and transitional programming instead of
- 3 returning an offender to a "hard bed" in a correctional
- 4 institution.
- 5 Furthermore, it has been determined that the offenders
- 6 housed at this minimum-security facility shall have violated
- 7 probation, parole, or furlough by illicit substance use, or are
- 8 sentenced felon probationers, or sentenced misdemeanants
- 9 identified as high risk for illicit substance use or recidivism.
- 10 The minimum-security facility shall also have the capacity
- 11 to house adult males in a furlough program in a minimum-security
- 12 setting.
- 13 The legislature further finds that the department of health
- 14 is statutorily required pursuant to section 26-13, Hawaii
- 15 Revised Statutes, to administer programs designed to protect,
- 16 preserve, care for, and improve the physical and mental health
- 17 of the people of the State. The legislature finds that the
- 18 department of health has access to the best personnel to provide
- 19 substance abuse treatment and support services, cognitive
- 20 behavioral intervention, and transitional programming in lieu of
- 21 incarceration.

1 The purpose of this Act is to establish within the 2 department of public safety with assistance from the department 3 of health a minimum-security housing program for short-term 4 adult offenders in a county with a population of more than seven 5 hundred fifty thousand. 6 SECTION 2. Chapter 353, Hawaii Revised Statutes, is 7 amended by adding a new section to be appropriately designated 8 and to read as follows: 9 Minimum-security housing program; short-term 10 adult offenders. (a) There is established within the 11 department of public safety a minimum-security housing program 12 for short-term adult offenders in a county with a population of 13 more than seven hundred fifty thousand. The minimum-security 14 housing program shall be located at or near a community 15 correctional center and a prison. 16 The purpose of the minimum-security housing program is 17 to alleviate the overcrowded conditions of the State's community 18 correctional facilities and have the department of health 19 provide assistance in substance abuse treatment and support

services, cognitive behavioral intervention, and transitional

programming in lieu of incarceration.

1 SECTION 4. The appropriation made for the capital 2 improvement project authorized by this Act shall not lapse at 3 the end of the fiscal biennium for which the appropriation is 4 made; provided that all moneys from the appropriation 5 unencumbered as of June 30, 2022, shall lapse as of that date. 6 SECTION 5. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ or so much 8 thereof as may be necessary for fiscal year 2019-2020 and the 9 same sum or so much thereof as may be necessary for fiscal year 10 2020-2021 for the minimum-security housing program. The sums appropriated shall be allocated as follows: 11 12 for the hiring of staff to oversee the (1) 13 minimum-security facility; and 14 (2) for the operation of the minimum-security 15 housing program. 16 The sums appropriated shall be expended by the department 17 of public safety for the purposes of this Act. 18 SECTION 6. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ or so much 20 thereof as may be necessary for fiscal year 2019-2020 and the
