## A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF AGRICULTURE OPERATING BUDGET.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to provide funding
- 2 for the operations of the department of agriculture for the
- 3 fiscal biennium beginning July 1, 2019, and ending June 30,
- 4 2021.
- 5 SECTION 2. Unless otherwise clear from the context, as
- 6 used in this Act:
- 7 "Expending agency" means the executive department,
- 8 independent commission, bureau, office, board, or other
- 9 establishment of the state government (other than the
- 10 legislature, office of Hawaiian affairs, and judiciary), the
- 11 political subdivisions of the State, or any quasi-public
- 12 institution supported in whole or in part by state funds, which
- 13 is authorized to expend specified appropriations made by this
- 14 Act.
- 15 Abbreviations, where used to denote the expending agency,
- 16 shall mean the following:
- 17 AGR Department of agriculture

- "Means of financing" or "MOF" means the source from which
- 2 funds are appropriated or authorized to be expended for the
- 3 programs and projects specified in this Act. All appropriations
- 4 are followed by letter symbols. Such letter symbols, where
- 5 used, shall have the following meanings:
- 6 A General funds
- 7 "Position ceiling" means the maximum number of permanent
- 8 and temporary full-time equivalent positions authorized for a
- 9 particular program during a specified period or periods, as
- 10 denoted by an asterisk for permanent full-time equivalent
- 11 positions and a pound sign for temporary full-time equivalent
- 12 positions.
- "Program ID" means the unique identifier for the specific
- 14 program and consists of the abbreviation for the organization
- 15 responsible for carrying out the program followed by the
- 16 organization number for the program.
- 17 SECTION 3. The following sums, or so much thereof as may
- 18 be sufficient to accomplish the purposes and programs designated
- 19 herein, are hereby appropriated or authorized, as the case may
- 20 be, from the means of financing specified to the expending
- 21 agencies designated for the fiscal biennium beginning July 1,

- 1 2019, and ending June 30, 2021. The total expenditures and the
- 2 number of positions in each fiscal year of the biennium shall
- 3 not exceed the sums and the position ceilings indicated for each
- 4 fiscal year, except as provided elsewhere in this Act or as
- 5 provided by general law.

- 1 SECTION 4. Notwithstanding any other law to the contrary,
- 2 an appropriation made to a program by this Act may be combined
- 3 with appropriations made to the same program by any other Act
- 4 enacted by the legislature for the 2019-2021 fiscal biennium if
- 5 the combination is advantageous or convenient for budget
- 6 execution.
- 7 SECTION 5. If any portion of this Act or its application
- 8 to any person, entity, or circumstance is held to be invalid for
- 9 any reason, then the legislature declares that the remainder of
- 10 this Act and each and every other provision thereof shall not be
- 11 affected thereby. If any portion of a specific appropriation is
- 12 held to be invalid for any reason, the remaining portion shall
- 13 be expended to fulfill the objective of the appropriation to the
- 14 extent possible.
- 15 SECTION 6. If manifest clerical, typographical, or other
- 16 mechanical errors are found in this Act, the governor may
- 17 correct the errors.
- 18 SECTION 7. This Act shall take effect on July 1, 2019.
