A BILL FOR AN ACT

RELATING TO CONCESSIONS ON PUBLIC PROPERTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that section 102-2,
Hawaii Revised Statutes, appropriately provides that concessions
on public property are to be granted by sealed top-dollar bid,
with some exceptions.

5 Section 102-2, Hawaii Revised Statutes, also allows some 6 concessions to be exempt from bidding requirements because a 7 person or entity offering the most money may not be the best 8 suited or qualified to serve the needs of the public, including 9 the enhancement of customer and visitor experiences. Thus, the 10 legislature finds that cost and whether a concession is a for profit or nonprofit entity should not be the controlling factors 11 12 in awarding some concessions.

13 The legislature also finds that construction costs pose 14 challenges. While public leases may be granted for up to sixty-15 five years, concession contracts may not exceed fifteen years, 16 making it difficult for agencies to find concessionaires who are 17 willing to provide satisfactory concession services to visitors

1 and residents of the State. At various locations where 2 concessions are needed or warranted, it is difficult for 3 potential concessionaires to generate sufficient revenues to 4 support and amortize the concessions' construction and other 5 costs at the current lease and contract lengths of fifteen 6 years. Accordingly, the legislature believes that it is in the 7 public's best interests to provide flexibility and to authorize 8 the increase of the maximum length of a concession contract by 9 five years, from fifteen years to twenty years. Further, 10 determination as to whether a county zoo, botanic garden, or 11 other county park is environmentally, culturally, historically, 12 or operationally unique for the purpose of determining whether a 13 concession should be exempt from sealed bidding requirements 14 should be made by the director of parks and recreation of the 15 respective county.

16 The legislature also finds there is a need to provide more 17 historical and cultural information to address the needs of, and 18 to enhance, visitor experiences within the Hawaii capital 19 historic district and the increasing number of tourists and 20 residents visiting this district each year.

The board of land and natural resources may, subject to 9 chapter 102, dispose of concessions, as defined in chapter 102, 10 and shall enter into contracts or issue licenses for such 11 concessions; provided that the duration of the contract or 12 license shall be related to the investment required, but in no 13 event to exceed [fifteen] twenty years." 14 SECTION 4. This Act does not affect rights and duties that 15 matured, penalties that were incurred, and proceedings that were 16 begun before its effective date. 17 SECTION 5. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. 18 19 SECTION 6. This Act shall take effect on July 1, 2050.

Description:

Increases the maximum length of concession contracts from 15 years to 20 years. Replaces requirements that certain concessions shall be operated by nonprofit corporations in order to be exempt from the sealed bid requirements of section 102-2(a), Hawaii Revised Statutes, with a requirement that state and county agencies give preference to nonprofit corporations pursuant to rules. Provides that a county director of parks and recreation shall designate which county zoos, botanic gardens, or other county parks are environmentally, culturally, historically, or operationally unique for the purpose of determining whether a concession at the zoo, botanic garden, or other park is exempt from the sealed bid requirements of section 102-2(a), Hawaii Revised Statutes. Exempts from sealed bid requirements of section 102-2(a), Hawaii Revised Statutes, concessions on public property whose operations provide historical and cultural information, goods, and services within the Hawaii Capital Historic District. Takes effect 7/1/2050. (SD2)
