

A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii state
- 2 hospital in Kaneohe has been the long-term care facility
- 3 providing treatment for the State's forensic and non-forensic
- 4 mentally ill patients across the spectrum of acuteness. The
- 5 legislature also finds that the Hawaii state hospital has
- 6 reached capacity due to an overload of forensic patients, who
- 7 are individuals mandated by a criminal court to receive
- 8 treatment for mental illness. The Hawaii state hospital
- 9 currently has no capacity for non-forensic patients. Thus,
- 10 there is no option for non-forensic patients who need long-term
- 11 mental health treatment, many of whom suffer from a very high
- 12 degree of mental illness and are in critical need of long-term
- 13 professional care.
- The purpose of this Act is to establish a long-term care
- 15 facility that admits and treats non-forensic mental health
- 16 patients for in-patient or out-patient temporary case management
- 17 and to require that homeless patients receive priority admission

- 1 for treatment. As used in this Act, "non-forensic mental health
- 2 patients" shall not include individuals receiving treatment for
- 3 mental illness when that treatment is mandated by a criminal
- 4 court.
- 5 SECTION 2. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$2,000,000 or so much
- 7 thereof as may be necessary for fiscal year 2019-2020 and the
- 8 same sum or so much thereof as may be necessary for fiscal year
- 9 2020-2021 for the establishment of a long-term care facility
- 10 that admits and treats non-forensic mental health patients for
- 11 in-patient or out-patient temporary case management; provided
- 12 that homeless patients receive priority admission for treatment.
- 13 The sums appropriated shall be expended by the department
- 14 of health for the purposes of this Act.
- 15 SECTION 3. This Act shall take effect on July 1, 2019.
